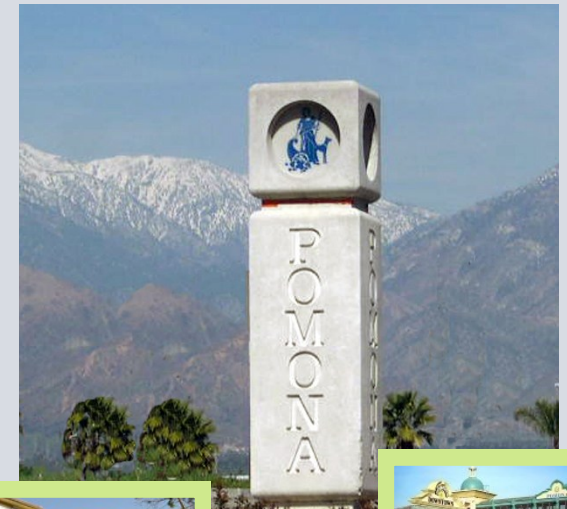
Commission applications are available on the City's website and in the City Clerk's Office. Submitted applications are kept on file for 1 year.

The City Council relies on a number of citizen boards, commissions and committees to serve as legislative advisory bodies to the Council. These legislative bodies play an important role in the governance of our City and provide valuable input to the City Council. Each entity is composed of local community members, and not only give private citizens the ability to participate in civic activities but also gives voice to specific issues that may not otherwise be addressed.

The City of Pomona encourages all citizens to participate in the various City boards, commissions and committees. Volunteers are appointed by the City Council to serve on each board, commission, or committee and serve with no compensation. The terms of office, qualifications, membership size, responsibilities, and meeting schedules vary for each board, commission, or committee.



#### **Board of Library Trustees**

*Every third Wednesday at 5 pm in the Library Public Conference Room*

The Board of Library Trustees oversees the management and operations of the Pomona Public Library. The Library Board may solicit funds for the sole benefit of the Library, subject to the City Council's approval.

#### **Planning Commission**

*Every second and fourth Wednesday at 7pm in the Council Chambers*

The Planning Commission is responsible for making discretionary decisions in compliance with the City's General Plan and Zoning Ordinance. The Commission conducts public hearings on Zone Change requests, Amendments to the Zoning Code, Conditional Use Permits, Variances, Environmental documents, Tentative Tract and Parcel Maps and other land use and development matters. In certain matters, such as zone changes and zoning code amendments, the Planning Commission makes recommendations to the City Council.

#### **Police Oversight Commission**

*Every third Tuesday at 6pm in the Council Chambers*  
The Police Oversight Commission was established by City Ordinance No. 4303. The purpose of the commission is to increase accountability of and public confidence in the Pomona Police Department, provide for an independent inspector general to assist in reviewing the police complaint process and provide a forum to review and evaluate and make recommendations about police and public safety.

#### **Vehicle Parking District (Board of Parking Place Commission)**

The City of Pomona's Vehicle Parking District (VPD) is administered by a seven-person commission that is responsible for regulating, (enforced by the Pomona Police department) 25 parking lots within the Downtown area. These include various duration parking including timed, permit, and lease parking lots.
