The four being promoted, all of whom will be trained in their new positions by the incumbents, have been with the gas company for at least nine years.

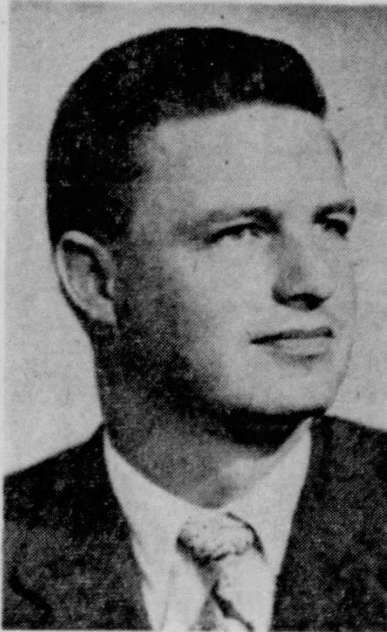

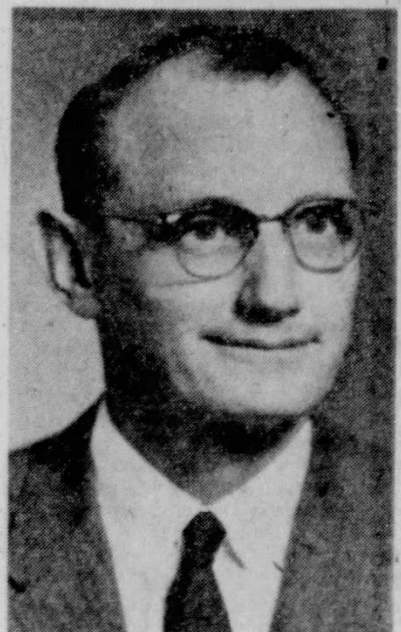

## Ganesha, Devil Spikers Vie Tomorrow

### Montview Loop Entry Seeks 2nd Victory Over Pomonans

### Pomona High Varsity Angling For 18th Straight Dual Win

City rivals Pomona and Ganesha, both boasting power-laden spike aggregations, run headon tomorrow in a much awaited meeting on the Red Devil track.

The Red Devils have clinched at least a tie for their second straight Tri-County League championship, while Ganesha is one of the favorites in the Montview League race.

The ever improving Giants of Coach Bud Petersen defeated Pomona (43 5/634) in a triangular meet won by Santa Ana last year. However, in dual meet competition Coach

Don Green's thindads have chalked up an impressive win streak of 17 in a row.

On paper, where few battles are won, the Giants rate the favorite role. Yet, in an arch rival meeting like this one the unexpected is given its best chance to develop.

Pomona must have a couple of "break through" performances to cut down the Giants and Ganesha is determined to prevent it.

Ganesha's Dave Crow, who already has proven himself to be one of the Southland's top hurdlers, is all but a "sure thing" in the stick events. He

has best races of 14.5 and 19.6 and Pomona hasn't anyone close to either time.

Dave McCarthy (low and high) and Bill Strang (down) also figure to be tough for the Red Devils to handle.

A wide open battle looms in the sprints with Ganesha's Dennis Nason and Chuck Chambers in the middle of the action. Both have 10 flat century times, while Chambers has the edge in the 220. Chambers, however, recently has been bothered with a leg injury.

Bob Ortiz will be rough to beat in the 440, while John Castaneda and Dennis Langford carry Ganesha's hopes in the half mile.

The Giants' Howard Grobe will have to top his best time of 4:45 in the mile by several seconds if he is to pick up a blue ribbon.

The "big event" in the field events will be the pole vault where Mike Flanagan and Pomona's Art Seagren tangle. Both have been over 13 feet with Flanagan's 133 1/4 the top mark.

Pomona is favored in the high jump and broad jump, but Fred Bellows, Strange and Crow may have something to say about it. Strang has a best of six feet in the high jump for the Giants' top entry. His 20.8 is a shade better than Bellows' top broad jump leap.

The shot put also figures to be tight, but Ganesha's Bob Buchanan definitely has been the most consistent of all performers. Giants' Rod Russell, Dennis Hughes, and Bill Marr are capable of surprising.

All in all, the form sheet leans toward the Giants and we're not one to go against the odds.

Pomona High's varsity track and field team hasn't lost a dual meet in the past three years but its streak will be in jeopardy tomorrow when Ganesha High motors across town to face the Red Devils.

Pomona won all seven of its dual meets in 1957, when it was a member of the Montview League, and the Devils swept through five dual meets untouched last season in the Tri-County League.

The Red Devils have won five consecutive dual meets this season, defeating Montclair and four TCL opponents. They'll be going for their 18th straight dual meet victory.

Tomorrow's action begins at 3:15 p.m. and the meet will be contested at the varsity, bee and cee levels.

The clash of the Red Devils and Giants has been picking up interest right along as both city schools show outstanding track talent. Pomona has clinched the TCL dual meet title and Ganesha is favored to bring home the Montview crown.

Additional bleacher seats will be placed at the Pomona track and the seating capacity is expected to be 400.

The full teams of the Red Devils and Giants met for the first time last season in a triangular meet with Santa Ana. Santa Ana scored 51.4 points to win with Ganesha in second (43.5-6) and Pomona in third (34). Santa Ana also took the bee division with Ganesha and Pomona in a deadlock for third. The Saints made it a sweep in the cee class with Pomona second and Ganesha third.

It was the only official meeting of the two city schools although they have been together in invitational meets and

face-to-face opposition often brings surprising results.

Pomona Coach Don Green shies away from a prediction but states all of his spikers "will have to come through with top performances."

Almost all of the events could go either way although Ganesha's Doug Crow, a transfer from Pomona, looks like a good bet in both hurdle events and the Devils' Doug Sailors appears solid in the mile. Crow lettered at Pomona as a sophomore and junior but switched to Ganesha this season.

The most exciting competition could be in the pole vault, where Pomona's Art Seagren meets Ganesha's Mike Flanagan. Seagren and Flanagan are old buddies who often practice together. Both are record holders at their respective schools. Flanagan also is an ex-Pomona High student.

Green will be counting heavily on his entire squad but much of the pressure will fall

on Sailors, Seagren, Gary Matheson, Bill McMillan, Bob Ranck, Carl James, Jim Bernard and Rich Merrell.

Matheson and McMillan are sprinters and also will be entered in a field event—Matheson the shot put and McMillan the broad jump.

Ranck and James are Pomona's top hopes in the hurdles with Ranck also in the broad jump and James in the high jump.

Bernard will carry Pomona's top hopes in the quartermile and also may enter the 200 where he edged teammates Matheson and McMillan Friday, in a meet with Claremont.

Merrell will be a "darkhorse" in the pole vault, hoping to edge out both Seagren and Flanagan. He also is Pomona's best high jumper and may be entered in the high hurdles.

Matheson, McMillan, Ranck and Bernard also will form the Red Devil relay foursome.

## VanAsten Disqualified

# Spike Honors to Seagren!

LOS ANGELES — Art Seagren and Pomona Valley's four-man mile relay team crowded state winners Ray VanAsten and Mike Flanagan out of the headlines here Saturday with surprise victories in the first annual Golden West Invitational prep track spectacular at East Los Angeles Stadium.

VanAsten, the national interscholastic record holder in the 880, was disqualified in the halfmile for "bumping," while Flanagan finished fifth in the pole vault.

Seagren, a last minute entry, scored a great upset by topping the classy pole vault field. Actually, he tied with Rex Wood and Floyd Guarra, the 14-5 vaulter from Tempe, Ariz., at 13-6, but the Pomona High grad had fewer misses.

Before he missed three times at 14 feet Seagren had

it enabled him to take the gold medal for first place.

Seagren cleared 13-6 on his 13 feet but went out at 13-6.

The four-man relay of Ricky Smith, Bill Strang, Jim Henry and Phil Buford won a two team mile race from San Fernando Valley in the time of 3:28.8. The same group hooked up with Dave Crow, Chuck Chambers, Phil Strona and VanAsten to finish second to Long Beach in a fine eight-man mile relay. The winners were timed in 3:02.1, while Pomona was clocked in 3:02.7.

It was a particularly disappointing day for VanAsten. The lanky 6-3½, 178-pound speedster never had a chance after the start. He was "boxed in" at the start and was unable to get out.

Running in fourth place, VanAsten pushed through Jan Underwood and Harry

Rhodes in the stretch in a vain effort to catch the front running Ron Whitney. However Whitney held off VanAsten's desperate bid to nip him at the wire in 1:54.4. VanAsten was second in 1:54.5, but disqualified. Rhodes, who was timed in 1:54.6, was awarded second with Underwood third and Robin Ruble third.

VanAsten summed up his showing with a disgusted, "It was a dumb race."

"But I sure wish I could run it again," he quickly added. He went on to say that he thought he would be able to get out of the box.

"I thought they (Underwood and Rhodes) would either move out or drop back and let me out, but it didn't work out that way."

The touted mile run was won by Ben Tucker from San Francisco Poly in 4:18.7. Joe

Hubie Watson squeezed out a 9.7 win over Jordan High teammate John Peters in the century, but Jimmy Douglas of North Miami, Fla., won the 220 in a photo finish with Watson. Both were timed in 22 flat.

Other top performances were turned in by Richard Inman of Belton, Tex., in the shot put with a toss of 62-11 and by broad jumper Walt Roberts, who leaped 23-8½.

A great field is shaping up for the Mt. San Antonio College Relays, April 26 and 27. Meet Director Hilmer Lodge has been attempting to lure Peter Snell, the world record holder in the mile, to Walnut but the plans of the New Zealand are remain doubtful at the moment . . .


Invitations to the Mt. Sac Relays have been mailed to millers Dyrol Burleson, Tom O'Hara, Cary Weisiger and Bill Dotson. The mile still seems to be the magic event and Lodge is hopeful of landing the best possible field . . .


One of the highlights of the Relays will be the mile relay event, where Arizona State, USC and Cal are already entered. The team from Texas Southern also may be in attendance and the Striders have a great group this season . . .

ABC May Carry Mt. Sac, Drake Penn Meets

ABC television is investigating the possibility of airing the Mt. Sac, Drake and Penn Relays simultaneously on its "Wide World of Sports" program. All three Relay events are

held on the same weekend. The telecast, if plans develop, would feature the top events in each meet . . .

Mt. Sac will be the host school for the Eastern Conference trials and finals and the Southern California JC trials and finals this season . . . the state meet will be held at Modesto, where the Mounties will defend their crown . . .

The local prep track and field season promises to be one of the best ever. Prep spike fans all over the country will be keeping an eye on Marc Savage, the Claremont High pole vaulter who cleared 147 1/4 Tuesday for the third best mark of all-time . . .

Pomona Valley Has Produced Top Vaulters

There probably isn't an area in the country which can match the prep pole vaulters turned out by the Pomona Valley. Last season three Ganesha athletes cleared better than 14 feet—Bob Richardson (14-3/4), Dave Hickson (14-1/2) and Doug Swartz (14-1/2). Pomona's Benny Brown cleared 13-3/4 last season while Claremont's Tim Buchanan made 13-1 and both of these boys—plus several other promising local prep vaulters—are back this season . . .

Two of the athletes who really did a lot to build interest in prep pole vaulting in the area are Mike Flanagan and Art Seagren. They had some great duels when Flanagan was at Ganesha and Seagren was at Pomona. Flanagan's best as a prep was 13-8 1/4 while Seagren did 13-6 1/4, both marks coming in 1960. Flanagan, of course, now is at USC while Seagren is at Mt. Sac . . .

One of the highlights of the local prep track and field season will be the Pomona-Ganesha meet, slated for April 18 on the Red Devil field. Ganesha won a thriller last season (53 1/6-50 5/6) and this year's meet should be about as close although it's too early to tell who should have the edge . . .

Track Interest in Bay Area at All-Time High

San Jose State Coach Bud Winter reports "Track interest in the Bay Area is at an all-time high thanks to last year's U.S.-Russian meet and last month's indoor meet in San Francisco. A lot of clocks in Northern California will be on a freshman sprinter at Cal, Forrest Beatty, who apparently has recovered from a 1962 pulled muscle . . .

Meets this Saturday find USC vs. BYU at the Coliseum; Oxy vs. Arizona State and Arizona at Tucson; UCLA and Rollands at San Diego State; Pepperdine and Pasadena AA at Los Angeles State; UC Santa Barbara at Long Beach State; San Fernando State at Pomona; and Cal Poly and La Verne at CMC . . .

Ray Van Asten, who was a key member of Mt. Sac's state JC championship team last season, could be a member of an NCAA title club this year. Ray, of course, is at Oregon and the Ducks have a fantastic spike cast despite the loss of Dyrol Burleson and Jerry Tarr.

## Gas Co. Franchise Payments Set Record

Southern Counties Gas Co. this week paid the highest franchise payments in its 52-year history to eight Southland counties and 99 of their cities, according to D. E. Shively, the firm's eastern division manager.

The record payment, Shively

said, totals \$1,998,693, up more than \$290,000 from the amount paid last year.

Of that total more than \$890,000 went to Los Angeles County and 48 of its cities while other funds will go to San Bernardino and Riverside County cities.

Of the funds sent to Los Angeles County cities, Pomona received \$53,794; Claremont got \$11,981; La Verne, \$6,277; San Dimas, \$7,837; Walnut, \$1,769; and West Covina \$37,930.

Cities in San Bernardino County receiving funds were Chino, \$9,097; Montclair, \$13,016; Ontario, \$36,659; and Upland \$16,891.

These franchise payments are made by all investor-owned gas, electricity and water utilities for the use of public streets and highways.

Shively said that the combined total of payments means that the gas firm paid an average of \$10.44 to local governments for each of their residents being served at the end of 1962.
