STAFF RECOMMENDATION

Staff recommends the Cultural Arts Commission choose three qualified artists to move forward to Part B: Proposals of this Art Call.

BACKGROUND

The City of Pomona launched The Garey Underpass Art Call (Part A: Qualifications) on September 5th, 2024, seeking artists or artist teams to submit qualifications to render, design and install artwork for the Garey Underpass on the two roadway walls on the Monterey Avenue side of the underpass. The Commissioned artwork is intended to support the public art component for Clean California Local Grant that the City of Pomona received for a proposal to "increase cleanliness, safety, accessibility, and beauty in the Holt Avenue Corridor."

The City had specific eligibility requirements for all applicants to meet in order for the submission to be taken into consideration—

City of Pomona Development Services Department Cultural Arts Commission Meeting of October 28th, 2024 We are seeking an experienced Artist or Artist Team residing or working in the Greater Los Angeles Area: Los Angeles County, Orange County, Ventura County, San Bernardino County, and Riverside County. Artists who have worked on at least one large scale mural project (more than 5,000 square footage). Artists who lack the experience with artworks of this scale are encouraged to form artist teams.

Artists will not be eligible to apply if they have been previously commissioned for a public artwork project by the City's Cultural Arts Commission in the last three years, whose budget was equal to, or exceeds, \$100,000. Artists who currently have contracts with the City will need to complete all projects before the deadline of Part A: Submission of Qualifications takes place to be considered.

This Call for Art closed on October 3, 2024, by 5PM PST. There was a total of 18 submissions, and of those 18 submissions only 8 met the eligibility requirements.
