

**RESOLUTION NO. 2024-188**

**A RESOLUTION AMENDING THE FY 2024-25 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY UNAPPROPRIATING \$600,000 OF PROP C FUNDS FROM “HOLT AVE. (WEST) RECONSTRUCTION,” PROJECT NO. 428-2590-XXXXX-71047 AND \$500,000 OF PROP C FUNDS FROM “HOLT AVENUE CORRIDOR IMPROVEMENTS,” PROJECT NO. 428-2590-XXXXX-68575, AND APPROPRIATING THESE FUNDS TO “HOLT AVE. (EAST) RECONSTRUCTION,” PROJECT NO. 428-2590-XXXXX-71050**

**WHEREAS**, “Holt Ave. (East) Reconstruction,” Project No. 4285-2590-XXXXX-71050 requires additional funding for construction improvements; and

**WHEREAS**, the City Council desires to amend the FY 2024-25 CIP Budget by re-appropriating \$1,100,000 of Prop C funding from other CIP projects to “Holt Ave. (East) Reconstruction,” Project No. 428-2590-XXXXX-71050, in order to award the construction contract for paving improvements.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council amends the FY 2024-25 CIP Budget by unappropriating \$600,000 of Prop C funding (217-2590-89987-71047 CR; 428-2590-80736-71047 DR; 428-2590-66196-71047) from “Holt Ave. (West) Reconstruction,” Project No. 428-2590-XXXXX-71047.

**SECTION 2.** The City Council amends the FY 2024-25 CIP Budget by unappropriating \$500,000 of Prop C funding (217-2590-89987-68575 CR; 428-2590-80736-68575 DR and 428-2590-66196-68575) from “Holt Ave. Corridor Improvements,” Project No. 428-2590-XXXXX-68575

**SECTION 3.** The City Council amends the FY 2024-25 CIP Budget by appropriating \$1,100,000 of Prop C funding (217-2590-89987-71050; 428-2590-80736-71050 and 428-2590-66196-71050) to “Holt Ave. (East) Reconstruction,” Project No. 428-2590-XXXXX-71050

**SECTION 5.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
