A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING THE U.S. DEPARTMENT OF JUSTICE EDWARD BRYNE MEMORIAL JUSTICE ASSISTANCE GRANT AWARD IN THE AMOUNT OF \$57,719, AND AMENDING THE FY 2024-25 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS

WHEREAS, the U.S. Department of Justice (DOJ) requires that the City of Pomona formally accept the terms and conditions of the U.S. DOJ Edward Byrne Memorial Justice Assistance Grant (JAG) FY 2024 Local Solicitation awarded to the City in the amount of \$57,719;and

WHEREAS, the Police Department's expenditure plan for the U.S. DOJ Edward Byrne Memorial JAG FY 2024 Local Solicitation award will be used in (3) areas: gang violence suppression, community policing through the Police Department's Area Commander Program and human trafficking operations;

WHEREAS, the authority to accept the DOJ FY 2024 JAG grant and amend the FY 2024-25 operating budget by increasing revenue estimates and appropriations is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

- **SECTION 1.** That the City Council hereby accepts the DOJ Edward Byrne Memorial JAG FY 2024 Local Solicitation awarded to the City in the amount of \$57,719.
- **SECTION 2.** That the City Council hereby amends the FY 2024-25 operating budget by increasing revenue estimates (239-2090-40875-58805) and appropriations (239-2090- XXXXX-58805) in the amount of \$57,719.
- SECTION 3. That the City Council hereby approves the Police Department's expenditure plan for the U.S. DOJ Edward Byrne Memorial JAG FY 2024 Local Solicitation grant, which will be used for gang violence suppression, community policing through the Police Department's Area Commander Program and human trafficking operations.
- **SECTION 4.** That the City Manager, or designee, is hereby authorized to execute any and all agreements on behalf of the City, in substantially the form submitted, subject to review and approval by the City Attorney.
- **SECTION 5.** That City Clerk shall attest to and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
