**SUBJECT: AMENDING THE FY 2025-26 MASTER FEE SCHEDULE BY ADDING THE CALIFORNIA DAYLIGHTING LAW (AB 413) PARKING CITATION FEE**

## **RECOMMENDATION:**

It is recommended that the City Council adopt the following resolution (Attachment No. 1):

**RESOLUTION NO. 2025-82 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2025-26 MASTER FEE SCHEDULE BY ADDING THE CALIFORNIA DAYLIGHTING LAW (AB 413) PARKING CITATION FEE UNDER POLICE SERVICES FEES**

## **EXECUTIVE SUMMARY:**

California's "Daylighting Law" went into effect January 1, 2025, per Assembly Bill 413 ("AB 413"). Under California Vehicle Code section 22500(n)(1)(A), a motor vehicle is prohibited from parking, stopping, or standing within 20 feet of the vehicle approach side of any marked or unmarked crosswalk. The proposed resolution will add the California Daylighting Law parking citation fee of \$68.45 to the FY 2025-26 City of Pomona Master Fee Schedule.

**FISCAL IMPACT:**

This fee is estimated to increase revenue by approximately \$100,000 (General Fund Acct #101-2014-40237-00000). At this time, there will not be an adjustment to the FY 2025-26 Operating Budget. Staff will evaluate the revenue received during the mid-year budget process and make any necessary adjustments at that time.

**PUBLIC NOTICING REQUIREMENTS:**

A notice of the public hearing (Attachment No. 3) was sent to the Inland Valley Daily Bulletin with the publication dates of June 20, 2025, and June 27, 2025.

**DISCUSSION:**

Effective January 1, 2025, the California Daylighting Law (AB 413) enhances road safety by prohibiting vehicle parking, stopping, or standing within 20 feet of the vehicle approach side of any marked or unmarked crosswalk. AB 413 (Attachment No.2) amended Section 22500 of the California Vehicle Code to include Sub-Section 22500(n)(1)(A), which states:

*“22500. A person shall not stop, park, or leave standing any vehicle, whether attended or unattended, except when necessary to avoid conflict with other traffic or in compliance with the directions of a peace officer or official traffic control device, in any of the following places:*

*(n) (1) (A) Within 20 feet of the vehicle approach side of any marked or unmarked crosswalk or within 15 feet of any crosswalk where a curb extension is present.”*

If approved, the Pomona Police Department will be dedicated to educating the community about this new state law, along with future enforcement efforts. The parking citation fee will go into effect 60 days after Council approval.
