## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2017-2018 ADOPTED OPERATING BUDGET

**WHEREAS,** a fiscal review is a prudent method to ensure that the City maintains a healthy financial structure;

**WHEREAS**, the City routinely adjusts fiscal year appropriations and revenue estimates throughout the fiscal year;

**WHEREAS**, the City Council adopted the operating and capital improvement program budgets of the City of Pomona for fiscal year 2017-2018 on June 12, 2017 and June 19, 2017 and all appropriations for departments or major organizational units within the General Fund and all operating funds and capital improvements programs were approved;

**WHEREAS**, the City Council approved amendments to the fiscal year 2017-2018 General Fund Operating budgets on August 7, 2017, and October 2, 2017.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:
