### **RECOMMENDATION:**

It is recommended that the City Council take the following actions:

- 1) Adopt the following resolution:

**RESOLUTION NO. 2025-98– A RESOLUTION OF THE CITY COUNCIL  
OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2025-  
26 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES  
AND APPROPRIATIONS IN THE AMOUNT OF \$15,113**

- 2) Accept a Standards and Training for Corrections (STC) Grant from the Board of State and Community Corrections (BSCC) in the amount of \$15,113

### **EXECUTIVE SUMMARY:**

Action on this item will amend the FY 2025-26 Operating Budget by increasing revenue estimates and expenditures in the amount of \$15,113 and accept a Standards and Training for Corrections (STC) grant from the Board of State and Community Corrections (BSCC). These funds will be used to meet training and certification requirements for the Police Department's Jail staff.

**FISCAL IMPACT:**

Approval of this item will amend FY 2025-26 Operating Budget by increasing revenue estimates (215-2090-40873-58814) and appropriations (215-2090-5XXXX-58814) in the amount of \$15,113.

**PREVIOUS RELATED ACTION:**

On October 21, 2024, City Council accepted FY 2024-25 STC Grant for in the amount of \$13,860.

**DISCUSSION:**

The Police Department has been awarded a one-year STC grant in the amount of \$15,113 to meet the State of California's training requirements for our corrections personnel. The grant period covers July 1, 2025, through June 30, 2026; funds will be disbursed quarterly. The acceptance of the award is being brought retroactively because the notice of approval was sent by BSCC to the Police Department on July 2, 2025. This late approval did not allow the Department to prepare for Council action before the beginning of the grant performance period.

The STC program is a division of the BSCC. The purpose of the STC program is to provide funding for ongoing training and professional development for police corrections personnel. This STC Division develops standards for personnel selection, course certification, and training support.

**COUNCIL PRIORITIES & GOALS:** This item supports the 2021-2022 City Council Priority 1: Fiscal and Operational Responsibility – Goal C: Obtain additional grant funding and other revenues to help achieve City goals.
