

**RESOLUTION NO. 2025-74****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX A OF THE COMPENSATION PLAN FOR EXECUTIVE MANAGEMENT GROUP A AND B EMPLOYEES BY ADDING THE CHILDREN & YOUTH SERVICES DIRECTOR CLASSIFICATION**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges to the Compensation Plan for Executive Management Group A and B Employees (A-B Plan) of the City of Pomona;

**WHEREAS**, the City Council has the authority to amend the staffing allocations;

**WHEREAS**, on November 6, 2023, the City Council adopted Resolution No. 2023-219 amending the A-B Rules;

**WHEREAS**, the City Council has subsequently amended certain provisions of the A-B Plan by Resolution Number 2024-30 and 2024-87;

**WHEREAS**, in order to meet City's staffing needs, the City Council desires to amend Appendix A of the aforementioned Plan by the actions provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby authorize changes to be made to Appendix A of the A-B Plan by adding the classification of Children & Youth Services Director, as shown below:

Children & Youth Services Director	A-1	EA-096	\$163,864 – \$219,594

**SECTION 2.** That any portion of previously adopted Resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

**SECTION 3.** The action approved herein shall become effective July 13, 2025.

**SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its adoption.
