#### **PRESENTATIONS**

Mayor Sandoval presented the proclamation to Ann Mendoza, Pomona Valley Hospital Director of Nursing Administration, Tammy Feehling, RN Cardiac Surgery Administration, and the PVH Sidewalk CPR Education Team. PVH Staff expressed gratitude for the proclamation and encouraged community members to invite them to teach CPR at their community events.

Vice Mayor Garcia presented the proclamation to Chará Swodeck and various other members of the African American Advisory Alliance. Chará Swodeck expressed words of gratitude to thank those standing together in the empowerment of their community.

Mayor Sandoval read the proclamation.

John Beshay, Senior Project Manager at San Gabriel Valley Council of Governments, gave the presentation.

## MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Canales announced the upcoming Lunar New Year celebration at the Shaun Diamond Plaza.

Councilmember Preciado invited folks to attend the 2<sup>nd</sup> Saturday Art Walk and the upcoming District 2 Area Commander meeting. Councilmember Preciado attended the Kiwanis Bunco Night, and announced the next CommUnity Pull-Up event. Councilmember Preciado also attended the Martin Luther King Jr. Park ribbon cutting ceremony. Councilmember Preciado requested an update on the process for reporting illegal dumping, the street sweeping plan, and on the downtown trash enclosures.

Vice Mayor Garcia gave thanks to the community organizations that hosted a "Know Your Rights" workshop, and requested folks to be kind to neighbors. Vice Mayor Garcia announced that Girl Scout Cookie season had started.

Mayor Sandoval acknowledged the fear in the community and discussed the City's commitment to supporting immigrant and diverse communities. Mayor Sandoval also discussed a recent fire that had destroyed a building in the City and requested City Manager Scott to talk about the City's process on addressing vacant buildings.

City Manager Scott advised the City was taking proactive taking steps to demolish the damaged building and discussed the administrative process.

Councilmember Martin gave thanks to Camille, the representative from Assemblymember Rodriguez's office, for attending the meeting, and gave thanks to Lt. Haggerty for hosting the District 1 Area Commander meeting. Councilmember Martin attended a conference for newly elected councilmembers. Lastly, Councilmember Martin announced an upcoming community meeting at Ganesha Park.

#### **CITY MANAGER COMMUNICATIONS**

City Manager Scott gave an update on the Class and Compensation study.

#### **PUBLIC PARTICIPATION**

At the direction of the City Council Emergency Sub Committee, beginning with the July 18, 2022 Council meeting, emailed comments will no longer be read into the record during Council meetings. However, they will be included as part of the record/meeting minutes.

#### Live Comments were as follows:

Eunice Russell discussed her case against the City.

Cederic Ebener discussed safety concerns on Holt Ave. and asked the City to address those concerns.

Elizabeth Ebener discussed safety concerns on Holt Ave. and Towne Ave.

M. Joyce Bakersmith thanked the City for recognizing Black History Month, and expressed various concerns.

Rosuara Jimenez discussed concerns with the Pomona Police Dept. front desk hours and asked how the City defines "affordable" when describing new apartment developments.

Don Martens from Compassionate Pomona asked if the City could re-affirm a dedication to being a compassionate City and announced an upcoming Bingo fundraising event for the Pomona Host Lions Club.

Tremale Ratcliffe from Just Us 4 Youth lamented the passing of young residents, and requested to collaborate to develop an informational session for parents about the drugs presenting risks to kids and invited the community to attend the next Police Oversight Commission meeting.

It is recommended that the City Council take the following actions:

- 1) Award a construction contract to the apparent lowest responsive bid from Garcon Construction, Inc. for "ADA Curb Ramps and Path of Travel (CDBG) (FY 23-24)," Project No. 428-2590-XXXXX-67941, to include all Base Bid items, plus Additive Alternate Items No. 1 3 in the total amount of \$713,398;
- 2) Find that the project referenced above is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301(c) and that the proposed project will not have a significant effect on the environment; and
- 3) Authorize the City Manager to execute the construction contract and any subsequent change orders on behalf of the City of Pomona (City).

Mayor Sandoval commented on the positive effects of Measure PG, asked various questions to Jim Morris, and expressed support for the payout to the CalPERS UAL

Councilmember Lustro gave comments and expressed support for the payout to the CalPERS UAL.

Vice Mayor Garcia gave comments and asked various questions to Finance Director Mowbray. Vice Mayor Garcia expressed support for the payout to the CalPERS UAL.

Councilmember Martin asked various questions and Economic Development Director Kirk Pelser answered Councilmember Martin's questions.

Councilmember Preciado expressed support for the payout to the CalPERS UAL and expressed a desire to find creative solutions.

Mayor Sandoval spoke about the importance of collaborating with the community to solve solutions to these challenges.

Councilmember Canales asked City Attorney Carvalho questions about the process for amending previously passed measures. City Attorney Carvalho answered Councilmember Canales' questions.

Jim Morris from UFI Financial Solutions gave closing comments.

**8.** Impact Analysis Report on the Possible Effects of the Proposed Initiative Petition to Repeal the City's Utility User Tax (UUT) on Water Service

It is recommended the City Council take the following actions:

- Receive and file the Impact Analysis Report on the possible effects of the proposed initiative petition to repeal the City's Utility User Tax (UUT) on Water Service;
- 2) Based upon the Impact Analysis Report, Submit the Measure to the voters at the "next regular municipal election," occurring at least 88 days later. Under Elections Code section 348, a "[R]egular election is an election, the specific time for the holding of which is prescribed by law." Under the recently amended City Charter, the City's next regular election will be its Primary Municipal Election, which will coincide with the Statewide Primary Election on June 2, 2026; and
- 3) Adopt the following resolutions:

RESOLUTION NO. 2025-10 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY OF POMONA AN INITIATIVE MEASURE REPEALING THE CITY'S UTILITY USERS TAX (UUT) ON WATER SERVICE, AT THE PRIMARY MUNICIPAL ELECTION TO BE HELD ON TUESDAY, JUNE 2, 2026

RESOLUTION NO. 2025-11 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO CONSOLIDATE A PRIMARY MUNICIPAL ELECTION TO BE HELD ON JUNE 2, 2026, WITH THE STATEWIDE PRIMARY ELECTION TO BE HELD ON THAT DATE PURSUANT TO ELECTIONS CODE SECTION 10403

RESOLUTION NO. 2025-12 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, PROVIDING FOR THE FILING OF PRIMARY AND REBUTTAL ARGUMENTS AND SETTING RULES FOR THE FILING OF WRITTEN ARGUMENTS REGARDING A CITY MEASURE TO BE SUBMITTED AT THE JUNE 2, 2026 PRIMARY MUNICIPAL ELECTION

MOTION BY VICE MAYOR GARCIA, SECOND BY COUNCILMEMBER LUSTRO, CARRIED 7-0, to receive and file the Impact Analysis Report on the possible effects of the proposed initiative petition to repeal the City's Utility User Tax (UUT) on Water Service; and submit the Measure to the voters at the City's Primary Municipal Election on June 2, 2026; and adopt Resolution No. 2025-10, Resolution No. 2025-11, and Resolution No. 2025-12.
