SUBJECT: AMENDMENT OF THE FY 2022-23 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CREATING A NEW PROJECT, "SWAMP COOLERS REPLACEMENT – FLEET SHOP"

### **RECOMMENDATION:**

It is recommended that the City Council adopt the following resolution:

**RESOLUTION NO. 2023-85 – A RESOLUTION OF THE CITY COUNCIL** OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2022-23 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY **UNAPPROPRIATING** \$56.142 OF **UNEXPENDED EOUIPMENT** MAINTENANCE FUNDS FROM "FLEET SHOP VEHICLE HOIST REPLACEMENTS," PROJECT NO. 428-2590-XXXXX-71056, CREATING A NEW PROJECT, "SWAMP COOLERS REPLACEMENT- FLEET SHOP," PROJECT NO. 428-2590-XXXXX-71087, AND APPROPRIATING \$56,142 OF EQUIPMENT MAINTENCE FUNDS AND \$27,238 OF WATER FUND **RESERVE TO THE NEW PROJECT** 

### **EXECUTIVE SUMMARY:**

City Council adoption of Resolution No. 2023-85 (Attachment No. 1) will create a new project, "Swamp Coolers Replacement – Fleet Shop," Project No. 428-2590-XXXXX-71087 (Project) and will unappropriate \$56,142 of Equipment Maintenance Funds from "Fleet Shop Vehicle Hoist Replacements," Project No. 428-2590-XXXX-71056 and will appropriate this funding and \$27,238 of Water Fund reserves to this new Project.

## **PREVIOUS RELATED ACTION:**

On June 4, 2018, the City Council adopted Resolution No. 2018-69 adopting the City's FY 2018-19 Capital Improvement Program budget that included the creation of "Fleet Shop Vehicle Hoist Replacement," Project No. 428-2590-XXXXX-71056.

### **DISCUSSION:**

The swamp coolers that are utilized to cool the Fleet Shop garages while City vehicles are being repaired are in disrepair and/or inoperable. As summer approaches, for the safety and well-being of Staff repairing vehicles, it is necessary to replace eight swamp coolers with new swamp coolers. The City of Pomona will be able to utilize a cooperative purchasing agreement with ACCO Engineering and can begin work immediately upon Council's approval of the recommended action.
