Whenever, any group of persons wishes to address the Community Life Commission on the same subject matter, the Chair may, at his/her own discretion, request that the group choose a spokesperson to address the Commission.*

- *All remarks should be addressed to the Community Life Commission as a whole, and not to individual Commissioners. Questions, if any, should be directed to the presiding Chair who will determine whether, or in what manner, an answer will be provided.*

- *Every person addressing the Community Life Commission will be limited to five (5) minutes or such reasonable time as is granted by the majority of the Community Life Commission.*
