c. All remarks should be addressed to the Community Life Commission as a whole, and not to individual Commissioners. Questions, if any, should be directed to the presiding Chair who will determine whether, or in what manner, an answer will be provided.

d. Every person addressing the Community Life Commission will be limited to five (5) minutes or such reasonable time as is granted by the majority of the Community Life Commission
