**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING A NEW WIRELESS COMMUNICATIONS SUBSCRIBER AGREEMENT BETWEEN THE CITY OF POMONA AND THE CALIFORNIA STATE POLYTECHNIC (CAL POLY POMONA) UNIVERSITY POLICE DEPARTMENT**

**WHEREAS**, the City of Pomona significantly benefits from current interoperability capabilities with other public safety agencies in Los Angeles and other counties;

**WHEREAS**, the City of Pomona is actively operating under the City of Glendale's ICI system with nine (9) strategically located cities for the purpose of creating and obtaining funding for a wide area public safety radio network to enhance current and future communication needs;

**WHEREAS**, the City of Pomona, with its current wide area interoperable radio network, has the legal authority and technical ability to host additional radio units;

**WHEREAS**, Cal Poly Pomona wishes to enter into a new Subscriber Agreement with the Pomona Police Department;

**WHEREAS**, Cal Poly Pomona would continue to utilize their existing radio and auxiliary equipment at no cost to the City; and,

**WHEREAS**, the authority to approve a new wireless communications Subscriber Agreement between the City of Pomona and Cal Poly Pomona is vested with the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby approves a new wireless communications Subscriber Agreement between the City of Pomona and Cal Poly Pomona.

**SECTION 2.** That the City Council authorizes the City Manager, or designee, to execute the agreement and all related documents on behalf of the City, as approved to form by the City Attorney.

**SECTION 3.** That the City Clerk shall attest and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
