

RESOLUTION NO. 2016-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE ADOPTED FY 16-17 OPERATING BUDGET BY APPROPRIATING \$4,500 FROM GENERAL FUND RESERVES, FROM PREVIOUSLY DONATED FUNDS FROM THE FAIRPLEX, FOR GANESHA PARK WOOD CARVING PLAQUES AND DEDICATION CEREMONY

WHEREAS, the City Council wishes to provide Pomona residents with aesthetically appealing parks and open space areas; and,

WHEREAS, The Fairplex, as a partner in that endeavor, in FY 14-15 provided a donation of \$50,000 to be used for improvements of the public park, open space, and rights-of-way in the Ganesha Park area; and,

WHEREAS, the City completed the installation of decorative river rock along the K-rails on Paige Drive in FY 14-15 at a cost of \$8,565 from the Fairplex donation for additional improvements; and,

WHEREAS, the City approved \$15,000 in funding for a Wood Carving Art Project that involved repurposing 13 dead redwood trees within the Soroptimist Redwood Grove and two tree stumps off of Paige Avenue within Ganesha Park into artful monuments featuring items such as forest animals or Native American themes; and,

WHEREAS, the City approved \$2,000 on April 4, 2016 for plant materials to compliment a memorial garden in Ganesha Park that Pomona Eagle Scout candidates are constructing to support a memorial plaque for dedication of the garden in honor of the Tongva Tribe of Native Americans; and

WHEREAS, the City approved \$7,000 on July 18, 2016 for the purchase of 15 granite identification plaques for the tree sculpture carvings in Ganesha Park, the purchase of a granite plaque honoring the Tongva Tribe of Native Americans for installation within a memorial garden in the Park, and an upgraded finish material of marine grade varnish, and,

WHEREAS, all appropriations lapse at the close of a Fiscal Year and an amendment to the approved FY 16-17 Operating Budget is required to appropriate an additional \$4,500 from The Fairplex donation to the General Fund for the purchase and installation of plaques for the individual tree sculptures and memorial garden, and an upgraded wood sculpture protective finish; and,

WHEREAS, upon approval of this resolution that appropriates \$4,500 there will be a remaining balance of \$15,748.66 from The Fairplex donation for additional improvements in the Ganesha Park area.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby amends the Adopted FY 16-17 Operating Budget by appropriating \$4,500 in the General Fund for Ganesha Park area improvements into Acct# (101-0150-52080-0000).

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its approval.
