

**RESOLUTION NO. 2017-**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ADOPTING A YOUTH EMPLOYMENT PLAN AGREEMENT WITH CALIFORNIA CONSERVATION CORPS – POMONA CENTER (CCC) FOR WORK ON CAPITAL IMPROVEMENT PROJECTS: ESPERANZA Y ALEGRIA PARK (FORMERLY ANGELA/CHANSLORE – NEW POCKET PARK), PROJECT NO. 428-2590-XXXXX-71029; PHILLIPS PAW PARK (FORMERLY PHILLIPS RANCH PARK – DOG PARK), PROJECT NO. 428-2590-XXXXX-71033; GANESHA PARK – TREE GROVE, PROJECT NO. 428-2590-XXXXX-71034; AND AUTHORIZING THE CITY MANAGER TO SIGN A SPONSOR AGREEMENT (CCC-96) ON BEHALF OF THE CITY**

**WHEREAS**, the people of the County of Los Angeles on November 3, 1992, and on November 5, 1996 enacted Los Angeles County Proposition A, Safe Neighborhood Parks, Gang Prevention, Tree-Planting, Senior and Youth Recreation, Beach and Wildlife Protection (the Propositions), which among other uses, provides funds to public agencies and nonprofit organizations in the County for the purpose of acquiring and/or developing facilities and open space for public recreation;

**WHEREAS**, the Propositions also created the Los Angeles County Regional Park and Open Space District (the District) to administer Proposition funds;

**WHEREAS**, the District has set forth the necessary procedures to govern applications for grant funds under the Propositions;

**WHEREAS**, the City of Pomona has complied with the District's procedures for submitting an application and has received approval of the grant (V-14);

**WHEREAS**, the award of Proposition grant funds contains assurances with which the City must comply in carrying out the Capital Improvement Program (CIP) Projects and requires the adoption of a Youth Employment Plan for the Projects; and

**WHEREAS**, the Pomona City Council certifies, that through this resolution, the City will enter into a Sponsor Agreement (CCC-96) with the California Conservation Corps – Pomona Center (CCC) to hire At-Risk-Youth for the three projects identified in CCC Form 58.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City of Pomona has or will have sufficient funds to operate and maintain the Project in perpetuity.

**SECTION 2.** That the Youth Employment Plan (Sponsor Agreement CCC-96) for Esperanza y Alegria Park (formerly Angela/Chanslor – New Pocket Park), Project No. 428-2590-XXXXX-71029; Phillips Paw Park, (formerly Phillips Ranch Park – Dog Park), Project No. 428-2590-XXXXX-71033; and Ganesha Park – Tree Grove, Project No. 428-2590-XXXXX-71034 is approved in substantially the form submitted and attached hereto as Exhibit A.

**SECTION 3.** That the City Manager is designated to execute the Sponsor Agreement (CCC-96), any amendments(s) thereto or extensions to the Agreement, payment requests and other documents that may be required for completion of CIP Projects: Esperanza y Alegria Park (formerly Angela/Chanslor – New Pocket Park), Project No. 428-2590-XXXXXX-71029; Phillips Paw Park, (formerly Phillips Ranch Park – Dog Park), Project No. 428-2590-XXXXXX-71033; and Ganesha Park – Tree Grove, Project No. 428-2590-XXXXXX-71034.

**SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its approval.
