WHEREAS, Ordinance No. 3662 was adopted on August 3, 1992, establishing a process for selecting and designating a member of the City Council to serve as Vice Mayor;

WHEREAS, an eight month period has lapsed requiring the appointment of a new Vice Mayor by the City Council, pursuant to Article II, Section 2-41 (a) of the Pomona City Code;

WHEREAS, according to the order of appointment set forth in Resolution 2015-6, the next designated Vice Mayor would be the Councilmember from District 2;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona, California, as follows:

SECTION 1. That pursuant to Pomona City Code, Section 2-41(b), the current order of appointment for the selection and appointment of Vice Mayor, as set forth in Resolution 2015-87, is as follows:

- 1. Councilmember from District 2
- 2. Councilmember from District 3
- 3. Councilmember from District 5
- 4. Councilmember from District 1
- 5. Councilmember from District 6
- 6. Councilmember from District 4

SECTION 2. That the City Council hereby selects and designates Adriana Robledo, Councilmember from District 2, to serve as Vice Mayor for an eight (8) month period, commencing on the date of adoption of this resolution.

SECTION 3. That in accordance with Pomona City Code Section 2-41(b), the order for the next selection and appointment of Vice Mayor shall be as follows:

- 1. Councilmember from District 3
- 2. Councilmember from District 5
- 3. Councilmember from District 1
- 4. Councilmember from District 6
- 5. Councilmember from District 4
- 6. Councilmember from District 2

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and it shall thereafter be in full force and effect.
