A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING PARTICIPATION IN THE FRANCHISE TAX BOARD'S CITY BUSINESS TAX PROGRAM AND AUTHORIZING THE CITY MANAGER TO EXECUTE REQUIRED CONTRACT

WHEREAS, the City Council of the City of Pomona deems it desirable to utilize the Franchise Tax Board's City Business Tax Program; and

WHEREAS, utilization of the Program will enhance efforts to collect appropriate and due business license taxes from businesses operating within city limits; and

WHEREAS, California Revenue and Taxation Code Section 19551.1 authorizes a reciprocal agreement for the exchange of specified tax information between a city and the FTB, and

WHEREAS, the City agrees that the information provided by the FTB will be used to administer the City's business tax program; and

WHEREAS, the agreement for participating in the City Business Tax Program must be executed by an authorized signer.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POMONA HEREBY RESOLVES AS FOLLOW:

SECTION 1. That the City Council of the City of Pomona wishes the City to participate in the Franchise Tax Board's City Business Tax Program for the term of the agreement; June 1, 2017 through December 31, 2019.

SECTION 2. That the City Manager is hereby authorized to execute the contract required for participation in the Program.

SECTION 3. The Clerk shall certify to the passage and adoption of this resolution, and it shall thereupon be in full force and effect.
