300. BOARD COMMUNICATIONS

Trustee Smith reported on the Board's participation in the City Christmas Parade. Trustee Macias welcomed the newly appointed Board members. Trustee Suarez announced that this would be his last meeting, as his term ends in February 2017. Trustee Smith thanked Trustee Suarez for his years of service on the Board.

Deputy City Manager Gluba presented a brief overview of board agendas and the steps required to approve a consent agenda.

Trustee Smith requested that Item 2 be pulled for discussion. Trustee Garcia suggested that the consent agenda be approved by line item.

MOTION BY TRUSTEE GARCIA, SECONDED BY TRUSTEE MACIAS, CARRIED BY VOTE OF THE MEMBERS PRESENT (7-0), TO APPROVE THE CONSENT AGENDA BY LINE ITEM.

MOTION BY TRUSTEE SMITH, SECONDED BY TRUSTEE MACIAS, CARRIED BY VOTE OF THE MEMBERS PRESENT (7-0), TO RECEIVE AND FILE THE MINUTES OF JULY 20, 2016.

Trustee Smith pointed out that the \$40,000 augmentation to the Library book budget does appear in the Financial reports. He inquired about the feasibility of using all the additional funds for book purchases given the impact this would have on staff, and suggested other uses for some of the money might be explored. Deputy City Manager Gluba and Library Manager Spill provided the Board with suggestions. Discussion ensued, including information about staffing limitations relative to PERS and City funding. Mr. Gluba asked for consensus of the Board to support the Library using the additional funds for materials other than books. Further discussion ensued. Pomona resident and Library Foundation president John Clifford voiced concern about using the money for materials other than books. He offered suggestions such as digitizing newspaper copy, electronic access, etc. Discussion continued, including comments about the Library website and the need to improve it for public access, patron requests for fax machine use, restroom baby changing tables, and DVDs.

MOTION BY TRUSTEE GARCIA, SECONDED BY TRUSTEE SMITH, CARRIED BY VOTE OF THE MEMBERS PRESENT (7-0), TO DIRECT STAFF TO ALLOCATE \$10,000 OF THE \$40,000 CITY COUNCIL AUGMENTATION FOR THE PURCHASE OF LIBRARY BOOKS, AND \$15,000 FOR RENOVATIONS AND UPGRADES TO FULFILL LIBRARY WISH-LIST.

It was noted that the Expenditures by Vendor and by Fund reports included in the Board packet were incorrect. Staff informed the Board that the correct reports would be emailed to the members. The Vendor and Fund reports were pulled from the Consent Agenda.

MOTION BY TRUSTEE SMITH, SECONDED BY TRUSTEE GARCIA, CARRIED BY VOTE OF THE MEMBERS PRESENT (7-0), TO RECEIVE AND FILE THE FINANCIAL & BUDGET REPORT, AND THE QUARTERLY REPORT.

Trustee Smith moved to nominate Trustee Jacqueline Macias as president of the Library Board of Trustees.

MOTION BY TRUSTEE SMITH, SECONDED BY TRUSTEE SUAREZ, CARRIED BY VOTE OF THE MEMBERS PRESENT (7-0), TO APPOINT TRUSTEE MACIAS PRESIDENT OF THE LIBRARY BOARD OF TRUSTEES.

MOTION BY TRUSTEE MACIAS SECONDED BY TRUSTEE GARCIA, CARRIED BY VOTE OF THE MEMBERS PRESENT (7-0), TO APPOINT TRUSTEE SMITH VICE PRESIDENT OF THE LIBRARY BOARD OF TRUSTEES.

Friends of the Library – Nora Garcia

Ms. Garcia reported on behalf of the Friends. She announced that the Friends Book Sales will be held quarterly on the second Saturday of the month. The next sale is scheduled for March 11, noon to 4 p.m., followed by sales on June 10, September 9, and December 9. She went on to explain how the Friends support the Library. Also, the Friends will have a Meet the Easter Bunny event on April 8.

Library Foundation - John Clifford

Mr. Clifford explained the purpose of the Foundation and cited its many accomplishments including: contributions to the Teen Center and Children's Room, the Homework Center, and the Cultural Enrichment Summer Program. Mr. Clifford reported that upcoming fundraising events will be announced.

Sustain/Support Our Pomona Public Library (SOPPL)—Alice Gomez
Ms. Gomez explained the purpose of SOPPL as a 501C4 organization. This designation allows them to engage in political activities. SOPPL will be involved in the April 29th Beautification Day project, targeting the Children's Room patio area.
