## **RESOLUTION NO. 2017-**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ENDORSING "POMONA'S PROMISE' AND ITS FIVE INITIATIVES USING THE COLLECTIVE IMPACT FRAMEWORK IN PLACE OF THE PREVIOUSLY ADOPTED POMONA YOUTH AND FAMILY MASTER PLAN.

**WHEREAS**, in 2006 the City Council demonstrated its concern for Pomona residents in addressing the need to promote a safer and healthier community by adopting the Pomona Youth and Family Master Plan (YFMP);

**WHEREAS**, the YFMP Steering Committee was tasked with the development of a comprehensive Action Plan and Implementation Strategy;

WHEREAS, ongoing meetings of the YFMP Steering Committee and its various subcommittees were held to develop an Action Plan and Implementation Strategy, addressing the three identified key risk factors of Academic Failure, Community Disorganization, and Favorable Youth Attitudes Toward Antisocial Behavior; and

**WHEREAS**, the resulting Action Plan and Implementation Strategy identified specific actions to: mobilize the community; establish and foster collaborations between Pomona families and various service providers; develop and coordinate existing programs and services that address the priority risk factors; and developed an evaluation process that ensured the implementation of the YFMP;

**WHEREAS**, in 2013 the YFMP Steering Committee was tasked with reviewing the goals and objectives of the YFMP based on current data and selecting goals and objectives for the next 10 years;

**WHEREAS**, YFMP Community Partners held the "Stopping Violence Stimulating Success" Summit to facilitate a community dialogue on the increase in violent crimes in 2014 in which five areas of focus were selected (Health, Academic Success, Public Safety, Economic Development and Communication and Community Engagement);

**WHEREAS**, following the Summit and goals and objectives review, the YFMP leadership decided on renaming YFMP and its efforts "Pomona's Promise".

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby adopt Pomona's Promise and the five initiatives (Healthy in Pomona, Education and Career Readiness, Crime Prevention and Public Safety, Economic Development and Community Engagement) using the Collective Impact framework in place of the previously adopted Pomona Youth and Family Master Plan noting that Pomona's Promise is a community based effort to which the City will serve as a partner.

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
