## OVERVIEW

**Recommendation** – That the City Council:

1. Award a construction contract in the amount of \$274,197 to California Professional Engineering, Inc. for the "Traffic Signal – Village Loop Road and Santa Clara Drive," Project No. 419-2590-xxxxx-50405; and
2. Authorize City Manager to execute the construction contract and any subsequent change orders on behalf of the City.

**Fiscal Impact** – The "Traffic Signal – Village Loop Road and Santa Clara Drive," Project No. 419-2590-xxxxx-50405 currently has a budget of \$357,000 funded from Series "AL"/"AM" Bonds and Measure R funds.

## **EXECUTIVE SUMMARY**

With Council approval of the recommended action, and based on the necessary traffic signal warrant analyses being satisfied, this project will entail the installation of a new traffic signal for all directions at the t-intersection at Village Loop Road and Santa Clara Drive. The new traffic signal will replace the current, all-way stop control.

## **DISCUSSION**

On March 1, 2017, a Notice Inviting Bids was posted on the City’s Public Notice Board and on the City’s website. The complete bid documents were also posted on the City’s website. The Scope of Work called for the installation of a new traffic signal at the t-intersection of Village Loop Road and Santa Clara Drive. On March 22, 2017, four bids were received and opened by the City Clerk, and the results are shown as follows:

The lowest responsible and responsive total bid and additive alternate combined, in the amount of \$274,197, was submitted by California Professional Engineering, Inc. A background and reference check was conducted during the week of March 27, 2017, which included contacting listed references and the verification of contractor’s license and insurance. California Professional Engineering, Inc. is registered with the Department of Industrial Relations, was found to be a responsible bidder and is appropriately licensed, bonded, insured, qualified, and competent to perform this work.
