

RESOLUTION NO. 2017-XXX
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA
ESTABLISHING BUSINESS LICENSE FEES FOR THE FINANCE DEPARTMENT

WHEREAS, it is the intent of the City Council to recover costs incurred in providing services in the Finance Department;

WHEREAS, Pomona City Code Section 50-337 authorizes the business license application fee to be set by resolution of the City Council;

WHEREAS, the Pomona City Code (Chapter 2, Article VI, Division 5) sets forth the method for establishing and increasing fees charged to recover costs reasonably borne by the City in providing services;

WHEREAS, the City considers four (4) fees to recover costs incurred by the Finance Department in providing business license services and these fees shall not exceed the City's actual costs of providing said services;

WHEREAS, for each fee, the City completed a cost analysis which is included in Exhibit "A" to this Resolution;

WHEREAS, the cost analyses were made available for review in the City Clerk's Office at least ten (10) days prior to the Public Hearing before the City Council on this Resolution;

WHEREAS, the City provided notice of the Public Hearing pursuant to Pomona City Code Section 2-925, and Government Code Sections 6062(a) and 66016; and

WHEREAS, on June 5, 2017, the City conducted a Public Hearing on the proposed fees set forth in the Resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby finds and determines that, based on cost analyses included in Exhibit "A" to this Resolution, the proposed fees are justified.

SECTION 2. That, as shown in Exhibit "A" to this Resolution, the City shall charge the following fees for business license services:

- Application for Business License \$45.00
- Application for Business License (Downtown) \$115.00
- Business License Renewal \$12.50
- Duplicate License \$9.00

SECTION 3. That the fees in Section 2 of this Resolution are hereby approved. Fees shall not exceed the amounts set by Section 2 above, except as approved by City Council Resolution.

SECTION 4. That the fees adopted herein shall be effective ten (10) days after the Mayor signs an Executive Order (below) stipulating that the City has complied with Chapter 2, Division 5, of the Pomona City Code, and no written appeal has been filed.

SECTION 5. The City Clerk shall attest and certify to the passage and adoption of this Resolution.
