

**RESOLUTION NO. 2017-\_\_\_\_\_****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE PERSONNEL RULES AND REGULATIONS FOR EXECUTIVE MANAGEMENT GROUP A AND B EMPLOYEES BY THE ACTIONS LISTED HEREIN**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges to the Personnel Rules and Regulations for Executive Management Group A and B Employees (A-B Rules) of the City of Pomona;

**WHEREAS**, on February 6, 2017, the City Council adopted Resolution No. 2017-12 amending the A-B Rules;

**WHEREAS**, the City Council desires to amend Appendix A of the aforementioned A-B Rules by adding classification(s) as provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby authorizes changes to be made to Appendix A of the A-B Rules' by adding the classification below.
