A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA CITY EMPLOYEES' CHAPTER OF THE TEAMSTERS LOCAL 1932 TO INCREASE THE SALARY SCALE OF THE POLICE DISPATCHER SERIES

WHEREAS, the City Council has the authority to create, classify and assign salary scales/ranges for Pomona City Employees' Association positions for the City of Pomona;

WHEREAS, on October 17, 2016, the City Council adopted Resolution No. 2016-147 adopting the 2016-2017 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona City Employees' Chapter of the Teamsters Local 1932 (PCEA), which also established a Roster of PCEA General Service Classifications;

WHEREAS, the City Council has subsequently amended certain provisions of the aforementioned MOU by resolution No. 2017-84; and

WHEREAS, the City Council desires to amend Appendix B of the aforementioned MOU by the actions herein;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby amends Appendix B of the PCEA MOU by adjusting the salary scale of the Police Dispatcher series by four (4) ranges (approximately 10%) as follows:

SECTION 3. That the salary increases approved herein shall become effective June 25, 2017.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
