A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA MID-MANAGEMENT / CONFIDENTIAL EMPLOYEES' ASSOCIATION BY CREATING THE CLASSIFICATION OF REVENUE OPERATIONS SUPERVISOR AND DELETING THE CLASSIFICATIONS OF REVENUE SERVICES SUPERVISOR AND CUSTOMER SERVICE SUPERVISOR

WHEREAS, the City Council has the authority to create, classify and assign salary scales/ranges for Mid-Management/Confidential classifications for the City of Pomona;

WHEREAS, on October 17, 2016 the City Council adopted Resolution No. 2016-148 adopting the 2016-2017 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Mid-Management/Confidential Employees' Association (PMMCEA), which also established a Roster of PMMCEA Classifications;

WHEREAS, the City Council has subsequently amended certain provisions of the aforementioned MOU by resolutions No. 2017-3; and

WHEREAS, the City Council desires to further amend Appendix B of the aforementioned MOU by the actions provided herein.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby authorizes amending Appendix B of the PMMCEA MOU by deleting the classification of Revenue Services Supervisor and Customer Service Supervisor and adding the classifications of Revenue Operations Supervisor.

SECTION 2. That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

SECTION 3. The action approved herein shall become effective July 9, 2017.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
