A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING STAFFING LEVELS ALLOCATIONS IN THE FISCAL YEAR 2017-18 OPERATING BUDGET AS A RESULT OF MERGER OF CUSTOMER SERVICE AND REVENUE SERVICES AND TRANSFER OF THE STORM WATER PROGRAM TO WATER RESOURCES

WHEREAS, the City Council approved the Fiscal Year 2017-18 General Fund Operating Budget on June 12, 2017; and
