**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF POMONA  
AMENDING THE POMONA CITY CODE BY REPEALING SECTION 2-  
522 PERTAINING TO THE REMOVAL OF COMMISSIONERS**

**WHEREAS**, Pomona City Code Section 2-522 requires a 4/5 Council vote for the removal of a commissioner, as adopted by Ordinance No. 3608 in 1991;

**WHEREAS**, Pomona City Charter Section 801 requires a majority Council vote for the removal of a commissioner, as approved by the voters in 1998;

**WHEREAS**, the City Charter provision is the controlling authority; and

**WHEREAS**, this ordinance repeals the conflicting language of PCC Section 2-522 regarding the removal of a commissioner.

**BE IT ORDAINED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That following language found at Pomona City Code Section Article V, Boards and Commissions, Section 2-522, Vote required for removal of member, is hereby repealed:

**Sec. 2-522.**

~~The following vote of the city council, not counting abstentions, shall be required to remove any member of any commission or board prior to the expiration of his term:~~

**SECTION 2.** That the City Clerk shall attest to the approval and passage of this ordinance, causing it to be posted as required by law, and it shall become effective thirty (30) days after its adoption.
