### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING A ONE-YEAR AGREEMENT WITH THE POMONA UNIFIED SCHOOL DISTRICT TO CONTINUE AND MUTUALLY FUND THE COMMUNITY SCHOOL RESOURCE OFFICER (CSRO) PROGRAM

**WHEREAS**, the Pomona Police Department and Pomona Unified School District (PUSD) have an extensive history of working on partnership projects that benefit youths and the community;

**WHEREAS**, part of these partnership projects include school truancy, parenting skills and after-school youth programs at elementary, middle and high school campuses;

**WHEREAS**, the Pomona Police Department and PUSD completed a three-year CSRO grant that provided enhanced school violence prevention education and safety to both elementary and middle school campuses;

**WHEREAS**, the Pomona Police Department and PUSD have developed a one-year Agreement that will mutually fund (2) Police Officer positions to continue the CSRO program for one additional year; and,

**WHEREAS**, funding for the City's portion of the CSRO agreement is included in the FY 2017-18 budget.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

<u>SECTION 1.</u> That the City Council hereby approves entering into a one-year agreement with Pomona Unified School District (PUSD) to continue and mutually fund the CSRO program.

**SECTION 2**. That the City Council hereby authorizes funding for the City's portion of the CSRO agreement in the amount of \$173,000 and authorizes the City Manager to execute the agreement with PUSD in substantially the form submitted.

**<u>SECTION 3.</u>** That the City Clerk shall attest and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
