A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA APPROVING A CONTRACT WITH THE LOS ANGELES COUNTY FAIR ASSOCIATION BY SETTING THE RATE FOR POMONA POLICE SERVICES DURING THE 2017 LOS ANGELES COUNTY FAIR AND AMENDING THE POLICE DEPARTMENT'S FY 2017-18 OPERATING BUDGET

WHEREAS, the Los Angeles County Fair Association desires to contract with the City of Pomona for Police Officers to provide security services during the 2017 Los Angeles County Fair:

WHEREAS, an additional expenditure appropriation of \$139,424 will be required to cover the total anticipated cost of the 2017 Los Angeles County Fair contract, which will be offset by an additional revenue of \$139,424 in anticipated reimbursement for same; and,

WHEREAS, Pomona City Code Section 46-562(b) provides the cost of security services to be provided by Pomona Police Officers shall be set by City Council resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. In accordance with the procedure set forth at Section 46-562(b) of the Pomona City Code, the rate for services provided during the 2017 Los Angeles County Fair by City of Pomona police personnel shall be one and one-half times the current wage for each employee providing services, plus Worker's Compensation and Federal Medicare Tax, when applicable, for each employee. An Administrative Fee of ten percent (10%) shall be applied to the total cost of the services provided.

SECTION 2. The amount to be paid to the City for providing basic police services, based upon the level of service, as determined by the Chief of Police, during the 2017 Los Angeles County Fair, is estimated at \$539,424, which includes the ten percent (10%) Administrative Fee.

SECTION 3. That the City Council amend the Police Department's FY 2017-18 operating budget estimates by appropriating an additional \$139,424 to cover the total anticipated cost of the 2017 Los Angeles County Fair (101-2002-51045-00000), which will be offset by additional revenues (101-2002-40177-00000) of \$139,424 in anticipated reimbursement for same.

SECTION 4. The Agreement between the CITY OF POMONA and the LOS ANGELES COUNTY FAIR ASSOCIATION for services to be provided by Pomona Police Officers during the 2017 Los Angeles County Fair (September 1 through September 24) is hereby approved, in substantially the form submitted.

SECTION 5. The City Manager, or designee, is hereby authorized to execute the Police Services Agreement on behalf of the City of Pomona, and the City Clerk shall attest to same.

SECTION 7. The City Clerk shall attest and certify to the passage and adoption of this resolution, and it shall thereupon take effect and be in force.
