

RESOLUTION NO. 2017-_____**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ADJUSTING SALARIES PURSUANT TO THE PROVISIONS OF THE 2016-2017 POMONA POLICE MANAGERS' ASSOCIATION MEMORANDUM OF UNDERSTANDING**

WHEREAS, on May 15, 2017, the City Council adopted Resolution No. 2017-66 adopting the 2016-2017 Memorandum of Understanding (MOU) for the Pomona Police Managers' Association (PPMA);

WHEREAS, the City is currently in negotiations for a successor MOU: and

WHEREAS, the City desires to further amend the PPMA MOU by increasing salaries by 2.5% in accordance with current provisions of the PPMA MOU.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Pomona as follows:

SECTION 1. That in accordance with the PPMA MOU for 2016-2017, the salary scales for the classifications of Police Lieutenant and Police Captain shall be increased by 2.5% effective October 1, 2017 to maintain the following salary alignment:

Police Lieutenant	20% above Police Sergeant
Police Captain	15% above Police Lieutenant

SECTION 2. That if any portion of previously adopted resolutions concerning salaries is inconsistent with this Resolution, the provisions of this Resolution shall prevail.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.

SECTION 4. The actions approved herein shall become effective October 1, 2017.
