

**RESOLUTION NO. 2017-149****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA  
ADJUSTING SALARIES FOR A-3 CLASSIFICATIONS PURSUANT TO  
THE PROVISIONS OF THE PERSONNEL RULES AND REGULATIONS  
FOR EXECUTIVE MANAGEMENT GROUP A AND B EMPLOYEES**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges to the Personnel Rules and Regulations for Executive Management Group A and B Employees (A-B Rules) of the City of Pomona;

**WHEREAS**, on October 17, 2016, the City Council adopted Resolution No. 2016-149 amending the A-B Rules; and

**WHEREAS**, the City Council desires to adjust salaries for Group A-3 classifications to reflect a 2.5% salary increase in accordance with the A-B Rules.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1.** That in accordance with the Personnel Rules and Regulations for Executive Management Group A and B Employees, the salary ranges for the classifications listed below shall be increased by 2.5% effective October 1, 2017.

**SECTION 2.** That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

**SECTION 3.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.

**SECTION 4.** The actions approved herein shall become effective October 1, 2017.
