

RESOLUTION NO. 2017 - _____**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR
2017-2018 ADOPTED OPERATING BUDGET**

WHEREAS, Adoption of Resolutions Approving 2.5% Salary Adjustment for Sworn Police Employees is effective October 1, 2017

WHEREAS, the City routinely adjusts fiscal year appropriations and revenue estimates throughout the fiscal year;

WHEREAS, the City Council adopted the operating and capital improvement program budgets of the City of Pomona for fiscal year 2017-2018 on June 12, 2017 and all appropriations for departments or major organizational units within the General Fund and all operating funds and capital improvements programs were approved;

WHEREAS, the City Council approved amendments to the fiscal year 2017-2018 General Fund Operating budgets on June 19, 2017 and August 7, 2017.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona, California, as follows:

SECTION 1. That the Fiscal Year 2017-2018 salary schedules for sworn personnel have been adjusted to reflect at 2.5% effective October 1, 2017 and has hereby been received and reviewed by the City Council.

SECTION 2. That the City Council amends the Fiscal Year 2017-2018 City operating budget to reflect appropriations for the purpose of accurately reflecting appropriations as follow:
