## **RESOLUTION NO. 2017-**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, AMENDING THE FY 2017-18 PUBLIC WORKS OPERATING BUDGET BY RE-APPROPRIATING \$254,274 (\$47,200 TO FUND 215-50900 AND \$207,074 TO FUND 245) FOR VEHICLES AUTHORIZED FOR PURCHASE IN FISCAL YEAR 2016-17

**WHEREAS**, the City approved the purchase of one medium-duty Compressed Natural Gas (CNG) truck in FY 2015-16 and re-authorized the purchase in FY 2016-17;

**WHEREAS,** the City approved the purchase of two additional vehicles (one medium-duty CNG truck and one heavy-duty CNG truck) in FY 2016-17;

**WHEREAS,** the City started the procurement of a fourth CNG medium-duty truck in FY 2016-17; and

**WHEREAS**, due to a delay in the required California Resources Air Board certification, the delivery of the three purchased vehicles is still pending, and the purchase of the fourth vehicle is delayed,

**WHEREAS**, as allowed by the City's Charter, the recommended actions will authorize the carryover of funding for purchase of the CNG trucks approved for funding and purchases during FY 2015-16 and 2016-17.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION** 1. Approve the vehicles purchased and procured as carryover from Fiscal Years 2015-16 and 2016-17 into FY 2017-18.

**SECTION 2.** Appropriate funding to FY 2017-18 Public Works Operating Budget, including \$207,074 of available Public Works Air Quality Management District (AQMD) Funds and \$47,200 of Public Works Cal Recycle Grant (HEART) Funds as depicted below:
