## **RESOLUTION NO. 2018-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF TWO CONTINUUM OF CARE PROGRAM GRANT AWARDS FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TOTALING \$1,286,636 IN GRANT FUNDING

- **WHEREAS**, on May 20, 2009 Congress enacted the HEARTH Act into law, consolidated homeless assistance programs administered by the U.S. Department of Housing and Urban Development (HUD) under the McKinney-Vento Homeless Assistance Act into a single grant program called the Continuum of Care (CoC) program;
- **WHEREAS,** the City of Pomona has been designated by the Los Angeles Homeless Services Authority (LAHSA), acting as the CoC lead agency for L.A. County, eligible to submit applications to HUD for CoC program grant funds;
- **WHEREAS**, the City has been awarded CoC program renewal grant funding from HUD to operate a Permanent Supportive Housing program, and a Rapid Re-Housing program for the current grant year term of April 1, 2018 to March 31, 2019;
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:
- **SECTION 1**. Authorize the acceptance of \$1,082,827 in CoC program grant renewal funds awarded by HUD to operate the Pomona Permanent Supportive Housing Program, formerly known as the Shelter Plus Care program.
- **SECTION 2**. Authorize the acceptance of \$203,809 in CoC program grant renewal funds, awarded through LAHSA, by HUD to operate the Pomona Homeless Outreach/Rapid Re-Housing Program.
- **SECTION 3.** Authorize the City Manager to execute the appropriate contracts and other documentation requested for acceptance of the award and operation of the above listed CoC programs for submittal to LAHSA and to HUD, subject to approval as to form by the City Attorney.
- **SECTION 4**. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
