## **RESOLUTION NO. 2018-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA MID-MANAGEMENT / CONFIDENTIAL EMPLOYEES' ASSOCIATION AND AMENDING THE AUTHORIZED STAFFING LEVELS IN THE NEIGHBORHOOD SERVICES, PUBLIC WORKS AND HUMAN RESOURCES DEPARTMENT FOR THE FISCAL YEAR 2017-2018 OPERATING BUDGET BY THE ACTIONS LISTED HEREIN

**WHEREAS,** the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

**WHEREAS**, the City Council has the authority to amend the staffing allocations;

WHEREAS, on October 17, 2016 the City Council adopted Resolution No. 2014-148 adopting the 2016-2017 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Mid-Management/Confidential Employees' Association (PMMCEA), which also established a Roster of PMMCEA Classifications;

**WHEREAS**, the City Council adopted the operating budget of the City of Pomona for fiscal year 2017/18 on June 5, 2017, which included the authorized Citywide staffing allocations;

**WHEREAS**, the City Council has subsequently amended certain provisions of the aforementioned MOU and authorized staffing levels by resolution numbers 2017-3, 2017-91, and 2017-96; and

**WHEREAS,** in order to meet department staffing needs, the City Council desires to amend Appendix B of the aforementioned MOU and further amend the authorized staffing allocations by the actions provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1**. That the City Council hereby authorizes changes to be made to Appendix B of the PMMCEA MOU by adding and deleting classifications as shown below.

<u>SECTION 2.</u> That the City Council hereby approves amending authorized staffing levels within the Fiscal Year 2017/18 Operating Budget by reclassifying one (1) Homeless Services Coordinator to Homeless Programs Supervisor in the Neighborhood Services Department; reclassifying one (1) Contracts Coordinator to Parks and Landscape Supervisor in the Public Works Department; and reclassifying one (1) Human Resources Technician/Analyst to Human Resources Analyst I/II in the Human Resources Department.

**SECTION 3.** That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

**SECTION 4.** The actions approved herein shall become effective March 4, 2018.

**SECTION 5.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
