

**RESOLUTION NO. 2018-**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA CITY EMPLOYEES' CHAPTER OF THE TEAMSTERS LOCAL 1932 TO CHANGE THE TITLE OF REHABILITATION SPECIALIST IN THE NEIGHBORHOOD SERVICES DEPARTMENT AND CREATE THE CLASSIFICATION OF PLANNING TECHNICIAN IN THE DEVELOPMENT SERVICES DEPARTMENT**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges for Pomona City Employees' Association positions for the City of Pomona;

**WHEREAS**, on October 17, 2016, the City Council adopted Resolution No. 2016-147 adopting the 2016-2017 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona City Employees' Chapter of the Teamsters Local 1932 (PCEA), which also established a Roster of PCEA General Service Classifications;

**WHEREAS**, the City Council adopted the operating budget of the City of Pomona for Fiscal Year 2017/18 on June 5, 2017, which included the authorized Citywide staffing allocations;

**WHEREAS**, the City Council has subsequently amended certain provisions of the aforementioned MOU and authorized staffing levels by resolution numbers 2017-84, 2017-90, and 2017-95; and

**WHEREAS**, in order to meet department staffing needs, the City Council desires to amend Appendix B of the aforementioned MOU and further amend the authorize staffing allocations by the actions herein.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby amends Appendix B of the PCEA MOU by changing the title of Rehabilitation Specialist and adding the classification of Planning Technician:

**SECTION 2.** That the City Council hereby approves amending authorized staffing levels within the Fiscal Year 2017/18 Operating Budget by 1) changing the title of two (2)

Rehabilitation Specialist positions to Housing Rehabilitation Specialist and 2) reclassifying one Program Assistant to Planning Technician.

**SECTION 3.** That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

**SECTION 4.** That the actions approved herein shall become effective March 4, 2018.

**SECTION 5.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
