## **RESOLUTION NO. 2018-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2017-18 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET REAPPROPRIATING FUNDING FROM "STREET PRESERVATION – CITYWIDE (FY 16-17), PROJECT NO. 428-2590-XXXXXX-67920 AND "EXCESS RDA BOND PROCEEDS ALLOCATION," PROJECT NO. 428-2590-XXXXXX-71041, COMMITTING FUTURE PROP C FUNDS IN THE AMOUNT OF \$4,582,505 (OF WHICH \$2,100,000 IS MATCHING FOR THE 2015 METRO CALL FOR PROJECTS AND \$2,482,505 IS NON-MATCHING FUNDS), AND APPROPRIATING \$515,975 OF SERIES AX BONDS (DISTRICT 2 ALLOCATION), STATE GAS TAX FUNDS, AND PROP C FUNDS TO "MAJOR STREET REHABILITATION – 2015 METRO CALL," PROJECT NO. 428-2590-XXXXXX-67918

**WHEREAS**, "Major Street Rehabilitation – 2015 Metro Call," Project No. 428-2590-xxxxx-67918, is included in the FY 2017-18 Capital Improvement Program (CIP);

**WHEREAS**, the City of Pomona wishes to reaffirm the commitment of future Prop C funds in the amount of \$4,582,505 (of which \$2,100,000 is matching for the 2015 Metro Call for Projects and \$2,482,505 is non-matching funds) for "Major Street Rehabilitation – 2015 Metro Call," Project No. 428-2590-xxxxx-67918;

**WHEREAS**, the City of Pomona wishes to provide funding for the construction contract award for segments of Mission Blvd Street Preservation which is Phase 1 of the "Major Street Rehabilitation – 2015 Metro Call," Project No. 428-2590-xxxxx-67918;

**WHEREAS**, the City of Pomona wishes to amend the FY 2017-18 CIP Budget for "Excess RDA Bond Proceeds Allocation," Project No. 428-2590-xxxxx-71041, by unappropriating \$240,285 Series AX Bonds (District 2 Allocation);

**WHEREAS**, the City of Pomona wishes to amend the FY 2017-18 CIP Budget for "Street Preservation – Citywide (FY 16-17)," Project No. 428-2590-xxxxx-67920, by unappropriating \$5,266 of State Gas Tax Funds, and \$270,424 of Prop C Funds; and

**WHEREAS**, the City of Pomona wishes to amend the FYI 2017-18 CIP Budget for "Major Street Rehabilitation – 2015 Metro Call," Project No. 428-2590-xxxxx-67918, by appropriating \$240,285 of Series AX Bonds (District 2 Allocation), \$5,266 of State Gas Tax Funds, and \$270, 424 of Prop C Funds.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council hereby amends the FY 2017-18 CIP Budget by:

- a. Committing future Prop C funds (FY 18-19 through FY 19-20) in the total amount of \$4,582,505 for "Major Street Rehabilitation 2015 Metro Call," Project No. 428-2590-xxxxx-67918 (of which \$2,100,000 is matching for the 2015 Metro Call for Projects and \$2,482,505 is non-matching funds);
- b. Amending the CIP Budget for "Excess RDA Bond Proceeds Allocation," Project No. 428-2590-xxxxx-71041, by unappropriating \$240,285 in Series AX Bonds (District 2 Allocation);
- c. Appropriating \$240,285 of Series AX Bonds (District 2 Allocation) to "Major Street Rehabilitation 2015 Metro Call," Project No. 428-2590-XXXXX-67918;
- d. Amending the CIP Budget for "Street Preservation Citywide (FY 16-17)", Project No. 428-2590-xxxxx-67920, by unappropriating State Gas Tax Funds in the amount of \$5,266;
- e. Appropriating \$5,266 of State Gas Tax Funds to "Major Street Rehabilitation 2015 Metro Call," Project No. 428-2590-xxxxx-67918;
- f. Amending the CIP Budget for "Street Preservation Citywide (FY 16-17)," Project No. 428-2590-xxxxx-67920, by unappropriating Prop C Funds in the amount of \$270,424; and
- g. Appropriating \$270,424 of Prop C Funds to "Major Street Rehabilitation 2015 Metro Call," Project No. 428-2590-xxxxx-67918.

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall become effective immediately upon its approval.
