Dear Linda,

We recently had a Grand Opening of the YMCA Early Learning Center here in Diamond Bar. The remodel was such a success and should give the Pomona Valley Y board members confidence in their difficult decisions these past couple of years. Our new relationship with the YMCA of Orange County allows both Y facilities in Diamond Bar to provide a stronger level of commitment to the community.

The Y will continue the core programs that are currently serving our local communities. We are strengthening our Maple Hill, Preschool and Afterschool programs located in Diamond Bar. We added an afterschool site at Decker Elementary last August and will open one at Pantera Elementary this coming August. All afterschool sites are currently located at PUSD schools.
