A RESOLUTION OF THE CITY COUNCIL, OF THE CITY OF POMONA, CALIFORNIA, APPROVING AN AGREEMENT FOR THE DOWNTOWN POMONA OWNERS ASSOCIATION TO PROVIDE PARKING LOT SWEEPING SERVICES FOR THE VEHICLE PARKING DISTRICT FOR AN INITIAL THREE-YEAR TERM WITH TWO, ONE-YEAR EXTENSIION OPTIONS AT AN ANNUAL COST OF \$40,560

- WHEREAS, the Vehicle Parking District (VPD) of the City of Pomona is seeking contractual parking lot sweeping service for all the parking lots in the District;
- WHEREAS, in 2012, the City Council awarded the Downtown Pomona Owners Association (DPOA) a contract to provide VPD parking lot sweeping services;
- WHEREAS, in 2014, the City Council extending the parking lot sweeping contract with the DPOA which ended on December 31, 2017;
- WHEREAS, the VPD will continue interim VPD parking lot sweeping services on a month-to- month basis until the end of May 2018;
- WHEREAS, on March 8, 2018, the City of Pomona / VPD released a "Request for Proposal" for parking lot sweeping services;
- WHEREAS, the bid submission deadline was March 21, 2018, and the DPOA was the only vendor to submit a bid for parking lot sweeping services;
- WHEREAS, the DPOA has been sweeping the VPD lots since 2012, and has performed such services very well and has an extensive knowledge of the VPD and Downtown Pomona;
- WHEREAS, a public procurement was conducted for VPD parking lot sweeping and the DPOA submitted a responsible qualified bid;
- WHEREAS, on April 12, 2018, the VPD Board of Parking Place Commissioners at their monthly standing Commission meeting recommended that the City Council award a Agreement for Contractor Services to the DPOA for VPD parking lot sweeping; and
- WHEREAS, the City desires to award a sole source Agreement for Contractor Service for parking lot sweeping to the DPOA as an efficient and effective manner of providing parking lot sweeping to all VPD lots.
- NOW, THEREFORE, BE IT RESOLVED by the City Council, of the City of Pomona as follows:
- **SECTION 1.** That, based upon staff reports, presentations, public testimony, and other matters presented during consideration of this matter, the City Council finds and declares the Resolution No. 2018 -

foregoing recitals to be true and correct, and are expressly incorporated as a material part of this Resolution.

SECTION 2. That the City Council hereby approves the VPD parking lot sweeping Agreement for Contractor Services; subject to the terms and conditions of the attached Agreement.

SECTION 3. That the City Council hereby approves the Agreement for Contractor Services setting forth the terms for VPD parking lot sweeping in substantially the form as attached hereto as Exhibit A, and authorizes the City Manager to execute the Agreement for Contractor Services on behalf of the City, and any extensions thereto.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
