

**RESOLUTION NO. 2018 - \_\_\_\_\_****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA  
AMENDING THE FISCAL YEAR 2017-2018 ADOPTED OPERATING  
BUDGET**

**WHEREAS**, a fiscal review is a prudent method to ensure that the City maintains a healthy financial structure;

**WHEREAS**, the City Council desires to amend authorized staffing levels in the Development Services Department;

**WHEREAS**, the City routinely adjusts fiscal year appropriations and revenue estimates throughout the fiscal year;

**WHEREAS**, the City Council adopted the operating budgets of the City of Pomona for fiscal year 2017-2018 on June 12, 2017 and all appropriations for departments or major organizational units within the General Fund and all operating funds were approved; and

**WHEREAS**, the City Council approved amendments to the fiscal year 2017-2018 General Fund Operating budgets on June 19, 2017, August 7, 2017, October 2, 2017, November 20, 2017, December 4, 2017, February 26, 2018, and March 19, 2018.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

**SECTION 1.** The City Council hereby amends the authorized staffing by adding the following positions to the Development Services Department: One (1) Senior Planner; one (1) Assistant Planner/Associate Planner; one (1) Planning Technician; and one (1) Administrative Assistant I/II/III.

**SECTION 2.** That the City Council amends the Fiscal Year 2017-2018 City operating budget to reflect additional appropriations for the purpose of accurately reflecting estimated appropriations as follows as it relates to this action.
