RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, STATE OF CALIFORNIA. AND THE SUCCESSOR AGENCY TO THE REDEVELOPMENT **AGENCY AUTHORIZING** THE **CITY** MANAGER/EXECUTIVE DIRECTOR TO SIGN A PETITION AND AN **REGARDING CITY PROPERTIES** ASSESSMENT BALLOT SUCCESSOR **AGENCY** TO THE REDEVELOPMENT **AGENCY PROPERTIES** THE AND WITHIN RENEWED, EXPANDED, DOWNTOWN POMONA PROPERTY AND BUSINESS IMPROVEMENT DISTRICT

WHEREAS, the Downtown Pomona Owners Association (DPOA) has begun the process to renew, and expand, the Downtown Pomona Property and Business Improvement District (DPPBID); and

WHEREAS, the DPOA Board formed the Downtown Pomona PBID Committee (Committee) to evaluate the renewal, and expansion, of the DPPBID; and

WHEREAS, the Committee developed and approved a Management District Plan and Engineer's Report (see Exhibit A) and are now moving forward with a petition process to authorize a ballot that would renew, and expand, the DPPBID; and

WHEREAS, under the provisions of Proposition 218 in the California Constitution, government agencies receiving special benefits must pay assessments in Property and Business Improvement Districts for the special benefit they receive; and
