The meeting was called to order at 7:00 p.m.

#### PLEDGE OF ALLEGIANCE

Councilmember Carrizosa led the Pledge of Allegiance to the Flag.

#### MAYOR/COUNCILMEMBER COMMUNICATIONS

Mayor Sandoval announced that item 10a would be continued to the next meeting; he informed the audience there were issues with the air conditioning noting this is why the lights were dimmed.

Councilmember Torres noted he spoke at the Fairplex Strategic Planning meeting in regards to transparency, housing and revenue generation; he also attended two Juneteenth Celebrations at Willie White and Ganesha Parks

Councilmember Robledo thanked the Pomona Kiwanis Club for fundraising for the Police Department's Great Camp Out where they raised about \$4,000.

Mayor Sandoval thanked Mr. Martinez, owner of a local Tai Kwon Do program, for the work he does with kids and for hosting an Olympics event; thanked Trudy Coleman, organizer of the Juneteenth Festival.

#### **CITY MANAGER COMMUNICATIONS**

City Manager Lowry informed that at the July meeting Staff would be bringing a budget amendment to create Capital Improvement Project for replacement of the air conditioning system for City Hall; she stated that Staff is looking at options and estimates it will be about \$1 million dollars to repair.

Councilmember Carrizosa requested that City Manager Lowry inform residents of the firework signs placed throughout the City.

City Manager Lowry informed that in order to raise awareness of the prohibition of fireworks within the City of Pomona Staff was encouraged, by Councilmembers Carrizosa and Ontiveros-Cole, to put signs out, they have been ordered, and they will be placed at public right of ways and parks; she stated they would be working with the City Council and Police Department to have the signs placed no later than the beginning of the week. Councilmember Carrizosa requested that the City collaborate with the Pomona Unified School District to place some signs at the schools, City Manager Lowry informed they would also request for the school district to place it on their reader board.

Councilmember Torres inquired and City Manager Lowry informed that the placement of the signs would be in the right of way where people drive so that it is visible and where there is a fire risk but that details had not been finalized.

Mayor Sandoval inquired and City Manager Lowry informed that Staff can work with the police department's dispatch to find out where calls regarding fireworks originate and place signs in those areas.

Councilmember Robledo thanked Councilmembers Carrizosa and Ontiveros-Cole for bringing awareness to the issue and informed that Vice Mayor Escobar is active in informing residents not use fireworks because of the dangers pose to the community.

#### PUBLIC PARTICIPATION

**Paola Avendando,** representative for Assemblyman Freddie Rodriguez, extended an invitation to the Health First Health Fair taking place on Saturday, June 24, 2017 in Washington Park from 1:00-4:00 p.m.; noted Senator Connie Leyva would be in attendance and thanked Councilmember Carrizosa for her assistance in planning the event.

<u>Soo Jin Kim</u>, from Live Wireless, shared concerns over fraud in the qualification process for Federal Life Line services; requested a meeting to discuss a plan that would be mutually beneficial to the City and her company. Mayor Sandoval referred Ms. Kim to contact AnneMarie from his office and provided a phone number to schedule an appointment with a Councilmember.

<u>Tahir Khan</u>, Local businessman in Pomona and Public Affairs Director of Ahmadiyya Muslim Community in Chino, extended an invitation to Mayor Sandoval, the Council Members and the audience to attend the annual Star Dinner on Thursday, June 22, 2017 at 6:30p.m. at the Mosque in Chino.

**Everia Condon**, Pomona, shared concerns and asked for advice about the response of staff regarding complaints specific to her property at 394 Roosevelt; these included dead peacock removal, street sweeping, and a parking ticket; Mayor Sandoval referred Ms. Condon to Public Works Director McWade and Police Chief Capraro for more information.

**Lorraine Flores** inquired about the process of requesting a playground be built at Hamilton park, between Holt and Mission Avenue; requested tree trimming near the basketball and handball courts at Hamilton Park and asked how to get a Neighborhood Watch sign installed at the Grand Terrace Apartments; Mayor Sandoval referred Ms. Flores to Public Works Director McWade and Police Chief Capraro for more information.

**<u>Christopher Kim</u>** spoke on the legalized marijuana industry in the surrounding cities of Adelanto, West Covina and Coachella Valley; inquired where Pomona wants to be in this marijuana legalization process; shared concerns from local business owners regarding the perception of their contributions to tax revenue and jobs.

**Randy Bekendam** commented that he has enjoyed coming and learning about the political process and inquired if it would be feasible to implement regular town hall meetings; Mayor Sandoval responded that they do have regular community engagement meetings and invited Mr. Bekendam to the monthly Coffee with a Councilmember on June 28th with himself and Councilmember Ontiveros-Cole tentative location is Carl's Jr. on Indian Hill.

<u>Elinor Crescenzi</u> asked that the resolution drafted by the United Voices of Pomona for Environmental Justice presented at the City Council Meeting on June 5, 2017, be brought before the Council at a future meeting; read the remaining portion of the Resolution aloud.

**<u>Ryan Sharif</u>** expressed opposition to the proposed dog park sharing that his children have enjoyed using the park, especially the proposed site, for sports activities and special events.

Darron Poulsen responded that it takes 60 days for the State to notify us that they have received the application; the application must be submitted before the end of this month; he defined an adjudicated basin as one bound by court order where all pumpers have come together to oversee the pumping versus an un-adjudicated basin having no orders on how much water can be pumped out of a basin.

Brad Johnson, Planning Manager clarified prior to giving a presentation on this item that the 3-3 Historic Preservation Commission vote was incorrect and the second vote taken was a 5-1-1 vote; Mayor Sandoval asked and received clarification that the 3-3 vote was to approve the removal of tree, and the 5-1-1 vote was to deny the removal of the tree.

Mr. Johnson showed pictures of the tree, gave a brief history noting he City had erroneously issued an exemption permit, when work started on the weekend, the Police Department and Code Enforcement departments were contacted; noted staff had concern that the tree was not receiving water, as the tree appeared to be wrapped at the base in a black tarp and retaining wall stones; he stated neighbors were concerned the homeowner is purposely trying to kill the tree; shared the property owner submitted an arborist letter that the tree is not healthy, however, the City arborist does not agree with that determination.

Councilmember Carrizosa inquired about the distance from the tree to the gate and if there had been any incidents of back up of the sewer line.

Mr. Johnson stated the Historic Preservation Commission recommended some cleanup of the tree and that the homeowner claims there have been sewer issues.

Councilmember Robledo inquired if the arborist had any information about the wrapping of the tree.

Mr. Johnson responded that the arborist was unsure of why the tree was wrapped. Councilmember Robledo inquired into the liability to the City due to the fact that the city issued the permit erroneously and the work had already started. City Attorney Alvarez-Glassman advised that even though the report was issued erroneously, the possibility of liability to the City is limited.

Christian Irias, homeowner of 366 W. Alvarado sent a letter regarding his need to appeal and requested to work with another person besides Brad Johnson; stated he was explained the process by Mr. Johnson, who was ill advised; shared that his neighbor, Robert Moore, told him Debra Martin called Code Enforcement on him. He submitted a Public Records request and the City Clerk responded that there were no responsive documents; a permit has been issued ten years prior; elaborated that Mr. Johnson could not explain to the Commission what the vote meant, they had to vote twice; a commissioner asked if he had a report from an arborist therefore he got one. He requested if his appeal was approved he be assigned an unbiased person to work with.

Hilda Magallanez spoke in favor of the tree removal; shared that the Historic Preservation Commission meeting on May 3rd seemed very informal and unorganized; noted there needs to be some type of guidance or process to make an informed decision; expressed concerns that it was not a fair vote, as the issue of the safety of the tree was abandoned, noting the vote was misunderstood, 5-1 vote was to trim it; the recommendation on the agenda was that the tree has been found to be safe by the City Arborist; requested that Mr. Johnson not be involved in the process moving forward.

Councilmember Torres requested a recap of the history; inquired if the applicant was issued a permit to remove his tree and if so, the reasoning.

Mr. Johnson responded that a permit was issued due to the property owner stating the tree was causing damage to the sewer line.

Councilmember Torres inquired how a property owner might prove a sewer or safety issues to City Staff.

Mr. Johnson noted residents are encouraged to provide documentation, video and consider consulting with the city Public Works Department or seek a City arborist's opinion and then go to the Historic Planning Commission for approval.

Councilmember Torres inquired into the process of reporting a city tree as a potential hazard and into alternatives presented to the applicant. Mr. Johnson confirmed three different options were presented to the homeowner.

Councilmember Torres asked who pays for this, if the tree takes more maintenance. Mr. Johnson noted that has only been one instance over the last 10 years where we got a claim to repair private sewer lines for a public tree.

Councilmember Torres inquired why a vote was missing on the commission. Mr. Johnson explained that Commissioner Debra Martin had to recuse herself from the vote because she owns property in the area.

City Attorney Alvarez–Glasman clarified that the decision of any elected officer to participate or not in a process is their individual decision; this was her decision to not participate.

#### MOTION BY COUNCILMEMBER TORRES, SECOND BY COUNCILMEMBER CARRIZOSA APPROVE REMOVAL OF THE TREE

Councilmember Gonzalez expressed appreciation for the historic district, however, stated there is a lot of red tape; spoke on the City's mistake and the fact that two certified licensed arborists approved removal of the tree; stated he will be abstaining from the vote; and commented should the Council deny the request to remove the tree, he feels the City should pay for the cost of cleaning the sewer lines.

Councilmember Carrizosa feels the situation was badly managed; noted Mr. Irias was a responsible citizen, who was granted the permit, he paid for it, and hired someone for the removal of the tree; expressed concerns that a former council member and commissioner stopped the process with no authority to stop anything.

Councilmember Ontiveros-Cole addressed Mr. Irias inquiring about the permit, the process and the condition of the tree.

Mr. Irias stated the tree is missing 22 limbs, is unbalanced and considered dangerous, leaning more towards the house than towards the street; noting that an arborist informed him that the Santa Ana Winds could knock it over.

Councilmember Ontiveros-Cole shared there is no possibility of the tree looking the same, now that it is cut the way that it is; understands why they made the decision that the tree is unsafe.

Councilmember Robeldo asked Mr. Johnson if the City considered using an independent arborist to provide input; expressed concerns with the tree causing damage; she supports Councilmember Torres' motion and encouraged Councilmember Gonzalez to vote.

Mayor Sandoval agrees with fellow Councilmember's; stated it was unfortunate that Mr. Irias was given information that was contradictory to the requirements; he commented that the mistake needs to be corrected and expressed the need to provide Mr. Irias with the proper process; noted Mr. Irias did hire a certified arborist whom stated the tree was a danger; Mayor Sandoval accepts that decision and supports that the tree needs to be removed.

Councilmember Ontiveros-Cole shared concerns of their tree; inquired if there had been a study regarding the roots.

Brad Johnson replied there had not been a study; noted that he added to the conditions of approval the option to use hand tools.

Councilmember Ontiveros-Cole inquired if the tree that remains will be salvaged or taken down.

Mr. Johnson informed the tree would be removed.

Councilmember Carrizosa inquired if the only conditions related to the tree were to use h

### MOTION BY COUNCILMEMBER ROBLEDO, SECOND BY COUNCILMEMBER GONZALEZ, to Open the Public Hearing

Mary Golbakhsh, Developer for the project, commented about reviewing the General Plan prior to submission; noted submitted modifications to the original plans regarding parking and number of bedrooms and eventually a reduction in the number of units; she commented on the shade study and crime; and encouraged Council to support the development.

Hank Fung, Civil Engineer, supports the project; reviewed the shade analysis, agrees with staff that no additional shade analysis should be required; commented that housing is a human right; stated the project is not denser than the surrounding neighborhood, it is within walking distance of transit, a great environment for people to grow up in, as they can continue gardening, and if the City denies the project, people may have to drive in from other cities, ultimately affecting Climate Change; he urged Council to support project.

Darren T. Navarro opposed the development. Lindsay Ann Taylor spoke in support of the project, noted benefits of low income housing.

Nathan C.E. Blush spoke in support of the project, noted it would lower crime rate and helps the surrounding area.

Erin W. Griswold commented that the region needs more housing; noted the unaffordability of the area and the potential commute to jobs.

Farnash Noroz Mazardarani, former resident of Pomona, spoke in support of the housing plan; encouraged an approval of the project; and commented on the crime rates in that area.

Sara Katherine Haase shared she has a lot of friends who want to buy homes but they have to move out of state due to cost therefore she supports low income housing; commented on the crime in the area; and noted the garden can coexist.

Delia Hitz, Sierra Madre resident, noted her strong support of farming and the rarity of this

specific type of farm; commented on the urban farming movement, crisis of food to low income areas, the environmental benefit, job creation and the relevance of 2 hours of shade; encouraged the Council not to vote on this item until they visit the farm.

Charles M. Young expressed support for the farm; commented on the impact of the development on the farm; shared proponents of the farm prepared an impact statement for the Planning Commission meeting; noted that without a report he feels there cannot be a determination that there will not be a negative impact on the farm.

Al Villanueva shared his grandfather taught him to value and respect the land; commented that the community garden improves health.

C. Freeman Allen, retired member of chemistry faculty; commented on the organization, Sustainable Claremont; mentioned State Law requiring a reduction in the amount of food waste that goes to landfill; shared he worked collaboratively to develop a plan to reduce food waste in Pomona; encouraged the Council to not do anything that will interfere with the garden.

Aaron Story did not wish to speak but was in opposition to the development.

Lynn Fang, Pomona resident, spoke in support of the garden; encouraged the Council to deny or ask the developer to reduce the height of buildings to one story; shared the garden should be considered a source of pride in the neighborhood; expressed her concerns that the developer has been negligible, stating they demolished a building without obtaining a permit.

Ingrid Gutierrez spoke in support of the garden; commented that she completed the farmer training internship; noted that the garden is beautiful, holistic, ecological, contains ground water, rain water, flowers, and pollinators all benefits; she strongly urged the Council to vote against the project.

Pablo Padilla spoke in opposition of the development; shared he participated in the farmer internship program; encouraged the Council to take time to review the plans and hold the developer accountable; noted the farm is already established and benefitting the City.

Charleen Fay Krueger, registered nurse, spoke in support of the farm; commented she has seen the health of residents get worse; she endorses healthy living and the ability to teach children and the community about the food they grow.

Sylvia Poreao, Orange County, commutes to Pomona three days a week to help at the farm; spoke in favor of the garden; commented about elevating agriculture, people are not valuing agriculture wisdom; noted, her daughter, Mayela Poreao has learned a lot from the farm; shared that the farm has helped her create her own family garden.

Elinor Crescenzi, Pomona resident; expressed that she stands behind the zoning code; expressed concerns about the negative impact of the development on the community.

Sara Tso did not wish to speak but supports garden and opposes the development.

Karen Chapman Lenz, Pomona, commented that she wants to spend the time she has left doing something that helps the world; shared she drives a Prius, doing her part about fossil fuels; encouraged those in attendance to eat local.

Traci Weamer, former farm intern, spoke about confusion regarding zoning codes and the rights of the developer; stated the developer does not have the right to develop their property.

Krysta Wandleboe, Claremont resident, volunteer at the farm, shared she learned a lot about growing food; noted the waste of a building is approximately 8,000 pounds of waste and expressed concerns about toxins used in home building.

Katie Lewis encouraged Council to review zoning for affordable housing because she has concerns that this project does not qualify and read aloud specific zoning code.

Randy Beckendam shared he built the farm five years ago, operated it for 2 years then turned it over to Mr. Kumar who cleared the land of all the debris, planted 30 fruit trees where there was already existing condominiums; noted 18 of those trees died because of the shade; encourages the developer to build one story buildings on that side of the property.

Manju Kumar provided clarification of how the garden runs; noted it is part of Saravadoya farms, its purpose is training and gathering of data on benefits of urban farming; shared that in 6 months they have trained nearly 50 students, including gardeners in the schools of Pomona.

Rishi Kumar, farm owner, spoke in opposition of the project; noted the project negatively impacts the garden in 3 ways; 1) Shade cast by buildings will impact <sup>3</sup>/<sub>4</sub> of the farm; 2) pollution from construction; 3) the developer has made no plans to mitigate the roots of a nearly 100 year old project. He stated he is not opposed to development of the property if the developer is able to abide by the previous mentioned items; commented that the garden provides free training, inspires and heals; he encouraged the Council to reject the current proposal.

Arthi Radhakrishnan, 2011 executive director Los Angeles County food policy council; commented the farm is a great example of urban farming providing free educational programs, donations to food pantries and data collection on urban farming; read statement by Clara Fosque, Los Angeles Food Policy Council.

Marco Barrantes spoke on the shade analysis that was conducted at the property; provided the findings that shade would impact growing in the winter months 3 hours in the morning and evening; commented this shows inaccuracy for the shade analysis completed by Torq; presented information on behalf of client, Rishi Kumar.

Reshama S. Damle spoke on behalf of Dr. John and Linda Barkman; shared that when they moved to the property the goal was to build their dream of growing a garden; expressed opposition to the development; stated it is too dense and the developer has not made any contact with them.

Iris Xu provided clarification on the shade; elaborated the significant impact of shade on growth in the existing garden; commented the development would create a loss of afternoon sunlight year-round, rendering the garden unusable.

Andrea Torres, Pomona resident lived two houses down from the farm, spoke in support of the garden; shared she is a professor and counselor at Mt. SAC and Chaffey college highlighting the educational and community opportunities the garden provides.

Cindy Soto expressed concerns that Torq Inc, is unfit to develop this project; stated that there has been no discussion with adjacent neighbors and Torq Inc. demolished a residence with no asbestos abatement; noted they have revised their plan, however, did not make changes based on the concerns of the community.

Carolyn J. Dasher, member of the grow club; read a letter from Ron Finley; shared the garden

has provided her training, ability to host classes and build community; noted the farm is dedicated to data collection utilized in research by future students; noted the garden is unique with its food internship program.

Kimberly Kirner spoke in support of the garden

Valentina Pro-Garcia also represented Raul Garcia, husband, shared that they enjoy the farm and its close knit community; expressed concerns that the development will be detrimental to the garden.

Alexandra Carbone, farm intern; shared the training at the farm assisted in securing her current teaching position as a gardening teacher at three Pomona Unified schools.

Santiago Ozo Noblin, spoke on the benefits of the farm for the people who volunteer; shared the experience is therapeutic and calming; encouraged the Council to listen to the public comment.

Laurette Lavin spoke in support of garden and its perception in the Pomona Community.

Andrew Quinonez -Service Corp Director, Earth Works Farm at El Monte; spoke in support of the farm; shared a model to work with non-profits to reduce negative behaviors in the community; encouraged the Council to make a positive judgment for the farm.

The following individuals did not wish to speak but were in opposition to the project:

Developer Mary Golbakhsh responded to public comments; clarified the homes in the project are available to first time home buyers, 0-3% down for those on a tight budget, it is not low income housing; commented on the shade analysis in correlation to the location of the development being north of the garden.

### MOTION BY COUNCILMEMBER CARRIZOSA, SECOND BY COUNCILMEMBER ROBLEDO to Close the Public Hearing.

Councilman Gonzalez commented on the attempts by volunteers and residents to find a compromise; noted that building 3 is the one building directly impacting the farm therefore if it became a one story and the bottom two units would be expanded it would make it a 13 unit development; stated this will maximize their profits and give some concession, however, the change from 14 to 13 units would require the developer to go back to the Planning Commission; he shared it would be ideal if the farm wasn't land locked, as it is already being affected and any further development would continue to affect it; inquired if the farm was a business with a permit who is in compliance, noting educational uses require a Conditional Use Permit.

Brad Johnson responded that the farm is in a zoning grey area, it could be defined as educational or public assembly category, however, still has questions; noted it to be included in the zoning code update.

Councilmember Gonzalez noted that when Mr. Rishi purchased the farm they were informed that the adjacent lot was to be developed for housing.

Councilmember Carrizosa commented that it was nice to see so many emails to save the farm, however, expressed concerns that many proponents were from out of town and presented that

part of Pomona in a negative view - as a food desert, low income, impoverished area, with high crime; noted the Council members reviewed and the crime figures in this portrayal are not correct, as that area has many markets; stated the City does have a housing issue; shared she supports the farm, but also the need for housing, hopes the two can co-exist; shared she visited the farm many times to get an understanding of the shade issue and feels the projects can coexist; building homes equates to property ownership which benefits everyone; she expressed an appreciation to everyone who spoke and stated she will vote in favor of the Developer.

MOTION BY COUNCILMEMBER CARRIZOSA TO APPROVE THE CONDITIONAL USE PERMIT (CUP 4607-2016) AND TENTATIVE TRACT MAP (TTM 49472016) TO ALLOW FOR THE CONSTRUCTION OF AN ATTACHED FOURTEEN UNIT RESIDENTIAL CONDOMINIUM DEVELOPMENT LOCATED AT 1198-1236 S. SAN ANTONIO AVENUE IN THE R-2-S (LOW DENSITY MULTIPLE FAMILY WITH SUPPLEMENTAL OVERLAY) ZONE

Councilmember Torres shared he is open to some form of middle ground; noted the City has a major homeless issue and this project may help to better that situation; expressed appreciation to those that shared their views and stated he will side with the Developer.

Councilmember Robledo stated Urban Farming needs to be addressed by developing policy; noted the farm is impactful throughout LA County and the city has an amazing resource to promote; commented about the need of a business license; encouraged staff to look at what other cities require, and if the farm requires a permit then the City needs to do its best not to deteriorate their positive momentum; she supports the recommendation Councilmember Gonzalez made and seconded the motion on the floor from Councilmember Carrizosa.

City Attorney Alvarez-Glassman advised to go back to planning to address the problems.

Councilmember Carrizosa noted that Council cannot force someone to add or remove specifics from a project, those decisions are based on land uses or codes.

Mayor Sandoval restated the question: Will this development have an adverse impact on the neighbors and the neighborhood?; he expressed it would be great to have a housing project on that site and stated that he respects the fact that people have different opinions; he noted that Council can require the developer to provide information; shared it is not a black and white issue, but rather an opportunity to build it and take the neighborhood into consideration; reiterated the importance to step back and let the Planning Commission determine an adverse impact.

Councilmember Robledo inquired if Mayor Sandoval would like to see the item come back?

City Attorney Alvarez-Glassman noted it is within the Council's authority to return the matter to staff, so they can speak with the Developer to ascertain if they want to modify the development and present it again.

Councilmember Ontiveros-Cole expressed appreciation for the project educating and bringing people together; inquired if there is a compromise between the community and developer; she concurs with Councilmember Gonzalez regarding the third building; encouraged the developer to speak to the community members and negotiate.

Developer Golbakhsh responded that they have been trying to reach out since 2014, as well as approach Mr. Rishi, all efforts were not welcomed.

Councilmember Ontiveros-Cole spoke in favor of a quality development inclusive of town homes, condominiums; she noted that she is divided as both sides are doing good things for the community.

Developer Golbakhsh elaborated specifics of the building height and the impact to the farm; noted the units proposed will provide ownership and not impact the community; stated she was at the meeting tonight to find out if the Council will allow them to build.

Councilmember Ontiveros-Cole asked if they are open to a 13 unit plan and working the community. Developer Golbakhsh responded that they asked if they could flip the plan to have the open space and common area on the other side of the property in an attempt to compromise; stated the change was submitted to planning three weeks ago.

Brad Johnson noted the city has not received a formal option B, however, there was a meeting with the Developer, and their architect did a design but there was not a specific plan submitted.

Developer Golbakhsh responded their plan to do is what the City is asking.

Councilmember Ontiveros-Cole encouraged harmony and agreement; called upon Mr. Kumar to come to some type of agreement that makes it possible for residents to become gardeners.

Mr. Kumar responded that he would gladly meet with the Developer; clarifying the issue is with the shade not the development; shared past interactions with the developer; confirmed he knew about the development when he took over in 2014; reiterated the impact of the shade of the development as proposed.

Councilmember Ontiveros-Cole inquired if Mr. Kumar would like to know more about flipping of the plan.

Developer Golbakhsh stated they were hoping to get an answer tonight but will give it another chance.

Mayor Sandoval shared he cannot support the project as it is currently configured because of new information; inquired into the willingness of Mr. Kumar and the Developer to sit down and arrive at an answer.

Mr. Kumar stated he is willing to meet although he is going to be gone all of July because he is getting married.

Councilmember Torres inquired if staff would be available to arbitrate an agreement.

Developer Golbakhsh responded that it is not economically feasible to drop down to one floor, but it does make sense to flip the location of the common area.

Mayor Sandoval stated a meeting would be a valuable opportunity to make revisions that are beneficial to both the developer and the farm and address some of the issues presented by the Planning Commission; noted it's a good project, however, he does not support it as currently configured; he inquired about the adverse impact on what he would call a "community treasure"; complimented the garden's strong sense of community, expressing that fundamentally it is about people being able to come together; Mayor Sandoval feels the developer has an opportunity to create a project that is forward thinking by incorporating the community garden.

Councilmember Carrizosa asked Brad Johnson if flipping the plan would mediate the concerns of the community and at the same time make the project feasible.

Brad Johnson responded the flip would have less of a shadow effect on the farm.

#### COUNCILMEMBER CARRIZOSA REQUESTED TO REMOVE HER INITIAL MOTION, AND MADE A SUBSEQUENT MOTION DIRECTING THE DEVELOPER AND MR. KUMAR TO COMMUNICATE DIRECTLY WITH CITY HALL, PLANNING DEPARTMENT, THE MAYOR AND COUNCIL MEMBERS, SECOND BY COUNCILMEMBER ROBLEDO.

City Attorney Alvarez-Glassman noted that a motion was necessary to reopen the public hearing.

Mayor Sandoval inquired and Mr. Kumar responded that he was leaving July 1st and returning home on July 30th

City Attorney Alvarez-Glassman advised a meeting was to take place between now and the end of the month to allow staff the opportunity to prepare the reports to be heard on August 7th. MOTION BY MAYOR SANDOVAL, SECOND BY COUNCILMEMBER CARRIZOSA to reopen the public hearing and continue the item to August 7th, CARRIED 6-0-0-1 (VICE MAYOR ESCOBAR WAS ABSENT)

City Manager Lowry stated scheduling of the meeting with the Developer and Mr. Kumar should be done in the next 48 hours, taking place at the City.

#### This item was continued to the August 7, 2017 City Council meeting.

#### MATTERS INITIATED BY CITY COUNCILMEMBERS

Mayor Sandoval shared that he and Councilmember Ontiveros Cole will be hosting Coffee with Mayor and Council Woman on June 28th at 6:30 p.m. at Carl's Jr.; invited anyone with time tomorrow morning to join a litter pickup around the Council area.

Councilmember Carrizosa stated that Renacimiento Community Center has been closed for too long, 2 months; inquired if the Council could help expedite the opening; noted there are close to 400 kids in the area; requested to use discretionary funds to provide the kids in that area with a ticket to go swimming.

# MOTION BY COUNCILMEMBER CARRIZOSA to provide tickets for the kids in the particular area to attend the swimming pool, SECOND BY MAYOR, 6-0-0-1 (COUNCILMEMBER ESCOBAR WAS ABSENT)

The City Council recessed into Closed Session to resume discussions of items on the Closed Session agenda at 11:59 PM.
