RESOLUTION NO. 2018-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, FOR THE ESTABLISHMENT OF A PREFERENTIAL PARKING DISTRICT IN THE AREA OF EAST PASADENA STREET AND SAN FRANCISCO AVENUE BETWEEN TOWNE AVENUE AND SAN ANTONIO AVENUE AND FINDING OF EXTREME HARDSHIP AND WAIVER OF PERMIT FEE

- **WHEREAS**, non-resident and an oversaturation of residential parking on City streets located on East Pasadena Street and San Francisco Avenue, bordered by Towne Avenue and San Francisco Avenue ("Preferential Parking District"), is causing extreme hardship among the residents of Pomona and negatively impacting their quality of life;
- **WHEREAS**, vehicles parked in the proposed Preferential Parking District area have resulted in increased litter, incomplete street sweeping, and lack of on-street parking for residents and their guests;
- **WHEREAS**, pursuant to City Code Section 58-239, the City Council may establish a Preferential Parking District, which will address the residents' concerns, and will also address the City's health and safety concerns regarding the accumulation of trash and debris and the potential for accumulated debris to enter the City's storm water system; and
- **WHEREAS**, the City mailed notices to the affected residents in advance of the Public Hearing as required by Pomona Municipal Code Section 58-239;
- **WHEREAS,** the City Council, on its own motion after considering public testimony, may establish a Preferential Parking District.
- **WHEREAS**, to avoid an undue burden and financial hardship on residents within the Preferential Parking District, the City Council has authority pursuant to City Code Section 2-4 to waive the permit fees.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:
- SECTION 1. The City Council hereby establishes the Preferential Parking District (the "District"), which will consist of City streets located at East Pasadena Street and San Francisco Avenue, bordered by Towne Avenue and San Francisco Avenue, as shown in Exhibit A, which is attached hereto and incorporated by reference. Overnight parking on these streets from 6:00 p.m. to 6:00 a.m. will require those vehicles to have a parking permit. Permit issuance is limited to one (1) guest permit only for each household/unit.
- **SECTION 2.** Because the City has initiated the formation of the District, which then imposes a permit requirement for on-street parking, along with permit fees, the City Council hereby makes finding of extreme hardship and waives the permit fee this Preferential Parking District.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
