**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges to the Personnel Rules and Regulations for Executive Management Group A and B Employees (A-B Rules) of the City of Pomona;

**WHEREAS**, on May 7, 2018, the City Council adopted Resolution No. 2018-50 amending the A-B Rules;

**WHEREAS**, the City Council desires to amend Appendix A of the aforementioned A-B Rules by adding and deleting classification(s) as provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:
