A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA MID-MANAGEMENT / CONFIDENTIAL EMPLOYEES' ASSOCIATION BY THE ACTIONS LISTED HEREIN

**WHEREAS,** the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

WHEREAS, on October 17, 2016 the City Council adopted Resolution No. 2016-148 adopting the 2016-2017 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Mid-Management/Confidential Employees' Association (PMMCEA), which also established a Roster of PMMCEA Classifications;

**WHEREAS**, the City Council has subsequently amended certain provisions of the aforementioned MOU by resolution numbers 2017-3, 2017-91, 2017-96, 2018-46, and 2018-47;

**WHEREAS,** in order to meet department staffing needs, the City Council desires to amend Appendix B of the aforementioned MOU.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1**. That the City Council hereby authorizes changes to be made to Appendix B of the PMMCEA MOU adding and deleting the following classifications shown below.
