## **RESOLUTION NO. 2018-**

- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE SUBMISSION OF THE "CITY OF POMONA ENHANCED STRATEGIC PLAN TO PREVENT AND COMBAT HOMELESSNESS" TO LOS ANGELES COUNTY, OUTLINING ENHANCEMENTS TO THE CITY OF POMONA'S "A WAY HOME" STRATEGIC PLAN
- **WHEREAS**, on December 6, 2016, the Los Angeles Board of County Supervisors adopted an ordinance placing Measure H on the March 7, 2017 countywide ballot to establish a quarter-cent countywide special sales tax for a period of 10 years to be utilized solely to prevent and combat homelessness; and,
- **WHEREAS**, on January 9, 2017, the City Council adopted a strategic plan on homelessness, "A Way Home: Community Solutions for Pomona's Homeless", outlining recommended solutions to address homelessness within the City of Pomona.
- **WHEREAS,** on March 7, 2017, the voters of Los Angeles County approved Measure H with 69.34 percent of the vote; and,
- **WHEREAS**, on June 13, 2017, the Board of Supervisors approved funding allocations for each of the Measure H eligible Homeless Initiative strategies that included \$2,000,000 in one-time funding to support coordination efforts of the Councils of Governments and planning efforts for cities in the Los Angeles Continuum of Care; and,
- **WHEREAS**, the City of Pomona responded to the Los Angeles County and United Way of Greater Los Angeles' Home For Good Funder Collaborative request for proposals and received an award of \$70,000; and,
- **WHEREAS,** in January 2018 the total estimated number of people experiencing homelessness in Los Angeles County was 50,385, with 3,615 (7%) of those counted living in Service Planning Area 3 (SPA 3) located in the San Gabriel Valley region, and 78% of those counted in SPA3 were unsheltered.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:
- **SECTION 1**. The City Council authorizes the submission of the "City of Pomona Enhanced Strategic Plan to Prevent and Combat Homelessness" to Los Angeles County, Chief Executive Office, outlining enhancements to the City of Pomona's "A Way Home" Strategic Plan.
- **SECTION 2**. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
