

**RESOLUTION NO. 2018-\_\_\_\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE ADOPTED FY 2018-19 POLICE ASSET FORFEITURE BUDGET AND APPROPRIATING \$61,660 FROM FUND BALANCE TO REPLACE THE HELICOPTER'S ROTOR HEAD/HUB**

**WHEREAS**, the Police Department's helicopter provides aerial support to Officers on the ground and is an integral part of Police field operations;

**WHEREAS**, at 3,000 flight hours, the helicopter requires a major overhaul on specific parts/equipment, with the need to install/replace new major parts;

**WHEREAS**, the helicopter is in need of a new rotor head/hub, which is a major component of the aircraft and is now required to be replaced per manufacturer specifications;

**WHEREAS**, MD Helicopters, who manufactures the part, has provided sole source service provider Rotorcraft Support, Inc. (RSI) in Van Nuys to perform the required work; and,

**WHEREAS**, the authority to amend the adopted FY 2018-19 Asset Forfeiture budget and appropriate funding is vested with the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby amends the adopted FY 2018-19 Police Asset Forfeiture budget.

**SECTION 2.** That the City Council appropriates \$61,660 from Asset Forfeiture fund balance into the appropriate line item (260-2000-52415-XXXXX) to pay for the required parts and labor.

**SECTION 3.** The City Clerk shall attest to and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
