A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING AN AMENDEMENT AND EXTENSION OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA POLICE OFFICERS' ASSOCIATION, INC. FOR THE PERIOD OF JULY 1, 2017 THROUGH JUNE 30, 2019

**WHEREAS**, the current Memorandum of Understanding between the City of Pomona and the Pomona Police Officers' Association, Inc. (PPOA) expired on June 30, 2017;

**WHEREAS**, City representatives negotiated a tentative agreement with the PPOA, which, if approved, will be for an extension and amendment of the MOU from July 1, 2017 through June 30, 2019; and

**WHEREAS**, the City Council has the authority to approve and ratify a contract with the City's employee associations.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California as follows:

**SECTION 1**. That the Extension and Amendment of the 2016-17 Memorandum of Understanding between the City of Pomona and the PPOA for the period of July 1, 2017 through June 30, 2019, attached hereto as Exhibit A, shall be approved, ratified, and ordered implemented.

- **SECTION 2**. That the City Manager of the City of Pomona is hereby authorized, empowered, and directed to enter into this Agreement for and on behalf of the City of Pomona.
- **SECTION 3**. The City Clerk is directed to attest the execution of the Extension and Amendment to the 2016-17 Memorandum of Understanding.
- **SECTION 4**. The City Clerk shall certify to the passage and adoption of this resolution, and it shall become effective immediately upon its adoption.
