**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA,  
CALIFORNIA, AMENDING THE FISCAL YEAR 2018-2019 ADOPTED  
OPERATING BUDGET**

**WHEREAS**, a fiscal review is a prudent method to ensure that the City maintains a healthy financial structure;

**WHEREAS**, the current Memorandum of Understanding between the City of Pomona and the Pomona Police Officers' Association, Inc. (PPOA) expired on June 30, 2017;

**WHEREAS**, the City routinely adjusts fiscal year appropriations and revenue estimates throughout the fiscal year;

**WHEREAS**, the City Council adopted the operating budgets of the City of Pomona for Fiscal Year 2018-2019 on June 4, 2018 and all appropriations for departments or major organizational units within the General Fund and all operating funds were approved;

**WHEREAS**, the City Council approved amendments to the Fiscal Year 2018-2019 General Fund Operating budgets on June 18, 2018.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

**SECTION 1.** That the Amendment and Extension to the 2016-17 Memorandum of Understanding between the City of Pomona and the Pomona Police Officers' Association, Inc. for the period of July 1, 2017 through June 30, 2019 has been approved.

**SECTION 2.** That the City Council amends the Fiscal Year 2018-2019 City operating budget by appropriating \$234,000 from General Fund reserves (101-2000-51012) to fund this action.

**SECTION 3.** The City Clerk shall certify to the passage and adoption of this resolution, and it shall thereupon be in full force and effect.
