

RESOLUTION NO. 2018-

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA,
CALIFORNIA, AUTHORIZING EXAMINATION OF SALES, USE AND
TRANSACTION TAX RECORDS**

WHEREAS, Hinderliter, de Llamas and Associates (HdL), as the City's contracted consultant for sales tax reporting, audit, and analysis, will require complete access to the Department of Tax and Fee Administration records; and

WHEREAS, the City Council of the City of Pomona deems it desirable and necessary for authorized representatives of the City to examine confidential sales, use and transactions tax records of the Department of Tax and Fee Administration pertaining to sales, use and transactions taxes collected by the Department for the City pursuant to that contract; and

WHEREAS, Section 7056 of the California Revenue and Taxation Code sets forth certain requirements and conditions for the disclosure of Department of Tax and Fee Administration records, and establishes criminal penalties for the unlawful disclosure of information contained in, or derived from, the sales, use and transactions tax records of the Department; and

WHEREAS, Avenu (previously MuniServices) shall be removed for examination of all sales, use and transactions tax and Hinderliter, de Llamas and Associates is hereby designated to examine the sales, use and transactions tax records of the State of California Department of Tax and Fee Administration pertaining to sales, use and transactions taxes collected for the City by the Department.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That HdL in their capacity as a contracted consultant to the City of Pomona, is hereby authorized to receive authorized to receive any and all relevant data from the Department of Tax and Fee Administration regarding the local collection of Sales, Use, and Transactions Taxes.

SECTION 2. That the City Council finds and determines that the following City Officials and employees of the City of Pomona are hereby authorized receive and review Sales, Use and Transactions Taxes information for the City of Pomona from the Department of Tax and Fee Administration and the City's contracted consultant.

SECTION 3. That Avenu (previously MuniServices) shall be removed for examination of all sales, use and transactions tax related to the City of Pomona.
